that pertains to that section. Senator Jacoby noted that depending on the length and difficulty of the assignment, the meetings may be changed from weekly to biweekly. Senator Jacoby mentioned that the Senators should proofread the section that they are given and if they come across a problem it should be brought up to the Committee on Government Operations. Senator Jacoby also mentioned that the Senators should speak to individuals who have a great understanding of what the scholarship is trying to accomplish.

- b.) The committee will assign individual scholarships addressed in title XIII of the SAS to the committee members.

Senator Jacoby explained that each member is assigned a scholarship and to go over specific sections within the SAS and how it correlates how the scholarship is being ran. All of these fall under title 13 under scholarships.

Senator Jacoby had been assigned chapter 1 of the SAS, which is Scholarships Generally.

Senator Duvall had been assigned chapter 3 of the SAS, which is the ASUN Daycare Scholarship.

Senator T Jackson had been assigned Chapter 6 of the SAS, which is the ASUN Nontraditional Student Scholarship.

Senator Jacoby noted that a when looking at the SAS, a large portion of them are similar to the scholarships that appear before, saying that many of the scholarships provide the same information.

Senator Jacoby gave an example saying that many of the scholarships have the same requirements, which include a 2.75 GPA and being enrolled in 12 credits. Senator Jacoby instructed the committee to ensure that the money that is allocated to the scholarships is being used wisely, to read over the chapter that each committee member was assigned, and to reach out to anyone who they believe would give necessary information about the Scholarship assigned.
