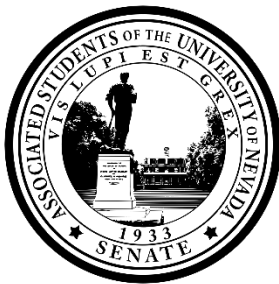

An Act to Award Kelly Doyle for 2017 Faculty of the Year

IN THE SENATE OF THE ASSOCIATED STUDENTS

APRIL 22, 2018

SUBMITTED BY SENATOR COLLINS TO THE COMMITTEE ON ACADEMICS

A Bill

An Act to Award Kelly Doyle for 2017 Faculty of the Year

1 *Whereas*, there is an established ASUN Faculty of the Year Award according to Title XXIV in
2 the Statues of the Associated Students (SAS).

3 *Whereas*, according to Title XXIV Section 2 the purpose of the ASUN Faculty of the Year
4 Award is to recognize exceptional University of Nevada Faculty.

5 *Whereas*, according to Title XXIV Section 6 the Senate Committee on Academics holds purview
6 over the selection of award recipients from applications received.

7 *Whereas*, the Committee on Academics is responsible for creating appropriate channels for
8 students to submit applications.

9 *Whereas*, students' nominations were collected through the 2018 Elections Ballot.

10 *Whereas*, 338 nominations were collected from the following survey question:
11 “Who do you recommend as an outstanding faculty member of the University of Nevada, Reno to
12 be selected as the 2017 Faculty of the Year? This may include any part-time or full-time professor,
13 administrative, or staff personnel on campus. Please state why you recommend the faculty member
14 selected in the above question.”

15 *Whereas*, the selection of the recipients shall be based on their impact on the learning
16 environment of students, the University, or their community.

17 *Whereas*, Kelly Doyle was nominated by 25 students from the 338 nominations.

18 *Whereas*, Kelly Doyle received the most nominations from the total 338 nominations.

19 *Whereas*, according to Section 6 the chosen winner shall receive a plaque of recognition and
20 legislation naming them the ASUN Faculty of the Year.

21 *Be it enacted that*, Kelly Doyle be formally awarded as the 2017 Faculty of the Year.

22 *Be it further enacted*, “Kelly Doyle, P.E.” receives a plaque from ASUN to be recognize as 2017
23 Faculty of the Year.

24 *Be it further enacted*, for this legislation to be sent to the Dean of the College of Engineering,
25 Manos Maragakis, the Provost Kevin Carmen, and the award recipient Kelly Doyle.
