**A RESOLUTION IN SUPPORT OF THE CREATION OF EXIT COUNSELING FOR  
GRADUATING STUDENTS**

- 1 *Whereas*, Postgraduate depression is commonly used to describe the extreme sadness and  
2 impaired functioning that recent graduates report after they leave behind the world they  
3 created in college;<sup>1</sup>

1 *Whereas*, A survey conducted by University counselors found that 36.4 percent of college  
2 students identify depression as a top concern;<sup>2</sup>

3 *Whereas*, In a survey conducted by the Independent, 95 percent of participants believed  
4 that post-university depression was very much a real thing, with a further 87 percent  
5 saying that there should be more exposure to it;<sup>3</sup>

6 *Whereas*, Financial exit counseling, regarding loans, is the only form of exit counseling  
7 currently offered to graduating students on-campus;

8 *Whereas*, Exit counseling would be targeted for graduating students at the University of  
9 Nevada to cope with being mentally prepared for graduation;

10 *Whereas*, In a survey conducted on an ASUN social media platform, 62 percent of survey  
11 participants identified they would attend exit counseling on-campus to prepare for  
12 graduation;

13 *Whereas*, Students identified feeling overwhelmed with student loans, fear of the  
14 unknown and feeling uncertain about getting a job after graduation;

15 *Whereas*, It has been found that group counseling has been known to be effective in  
16 regards to understanding the commonality of the struggles one faces with peers;<sup>4</sup>

17 *Whereas*, Group counseling creates a sense of belonging which has been found to be a  
18 key indicator of students' campus climate experiences as well as students' likelihood of  
19 academic success, social integration, and retention;<sup>5</sup>

1 *Whereas*, Having good social support from peers can help to alleviate some of the stress  
2 that graduate students may be experiencing;<sup>6</sup>

3 *Whereas*, According to the same study, by Nelson, increased interpersonal contact and  
4 social support were closely related to decreasing stress regarding graduation;

5 *Whereas*, Sustained or chronic stress, in particular, leads to elevated hormones such as  
6 cortisol, the "stress hormone," and reduced serotonin and other neurotransmitters in the  
7 brain, including dopamine, which has been linked to depression;<sup>7</sup>

8 *Whereas*, Exit counseling for graduating students will be a service that would reduce  
9 stress, depression and improve the mental health of students;

10 *Whereas*, Counseling services main mission is to provide psychological services to the  
11 University of Nevada, Reno students to support and facilitate their personal and academic  
12 success and development;<sup>8</sup>

13 *Whereas*, Counseling Services has requested a fee increase and Exit Counseling would be  
14 a form of expanding the services for students;

15 *Be it Resolved that*, Counseling Services will implement regular exit counseling for  
16 graduating students every fall and spring semester.
