SUBMITTED BY SENATOR DOYLE TO THE COMMITTEE ON GOVERNMENT OPERATIONS

A Bill An Act to Add Coalition Club Fairs to the Department of Clubs and Organizations

- Whereas, the Department of Clubs and Organizations holds club fairs during the beginning of
 the fall and spring semesters in order to give students a chance to explore the various clubs and
 organizations on campus;
 Whereas, the Club Commissioners are assigned a coalition to provide assistance to clubs and
 organizations throughout the entirety of the officer's term;
 Whereas, according to student feedback from clubs on the University of Nevada campus,
- 7 interest in more club fairs for their club type has been recorded;

- 1 Whereas, in order to promote the clubs within a coalition and give students a chance to interact
- 2 with specific types of clubs, it is important that smaller club fairs are held throughout the school year;
- Whereas, each commissioner should be in charge of planning a smaller club fair that is held for
- 4 either the entire coalition or a specific type of club within the coalition;
- 5 Whereas, some coalitions, like Campus Life, encompass more that one type of club so the
- 6 commissioner has the liberty to decide which group the club fair targets (ie: Art Club Fair);
- 7 Be it enacted by the Senate of the Associated Students, Club Commissioners within the Department of
- 8 Clubs and Organizations are required to hold one smaller club fair for clubs and organizations within
- 9 their coalition at least once during the officer's term;
- 10 Be it further enacted by the Senate of the Associated Students, the Statutes of the Associated Students
- 11 reflect Addendum A;
- Be it further enacted by the Senate of the Associated Students, the Department Procedures Manual for
- 13 Cubs and Organizations reflect Addendum B.

Addendum A

CHAPTER 202: DEPARTMENT OF CLUBS AND ORGANIZATIONS

SECTION 07: COMMISSIONERS

a) IN GENERAL:

There shall be at least 5 but no more than 8 Club Commissioners, nominated by the Director, with the consent of the Senate.

b) GENERAL DUTIES:

- Commissioners shall act as liaisons for the clubs and organizations in their coalition(s) appointed by the Director and the Department.
- 2) Commissioners shall review funding applications that have been submitted by clubs and organizations for Funding Hearings.
- 3) Commissioners shall attend weekly Department meetings to give a report on projects, initiatives, and general updates on their coalition(s).
- 4) Commissioners shall serve as a resource to club leaders in their coalition(s) for assistance with club recognition, club renewal, and funding.
- 5) Commissioners shall reach out to each club in their coalition in an attempt to attend meeting or activity per year at the discretion of the director of the Clubs and Organizations department.
- 6) Commissioners shall mentor and educate Department of Clubs and Organizations Intern(s) that the Interns are assigned to.

- 7) Commissioners are required to plan one (1) club event or fair for clubs and organizations within the officers assigned coalition at least once during the officer's term
 - i. Example: The Commissioner in charge of Campus Life can plan a club fair for the art and music clubs and organizations within the coalition

A BIII TO CHANGE PROCEDURES REGARDING FRATERNITY AND SORORITY LIFE AND RECREATIONAL SPORTS

- 1 Whereas, student organizations within the Office of Fraternity and Sorority Life (FSL) are
- 2 required to gain recognition through their department and through the Associated Students of the
- 3 University of Nevada (ASUN);
- 4 Whereas, currently the required membership minimum for Clubs and Organizations is seven (7);
- 5 however, there are approximately seven (7) organizations currently recognized by the Office of
- 6 Fraternity and Sorority life that do not meet the ASUN recognition requirements;

1	Whereas, shifting the recognition to solely happen through the Office of Fraternity and Sorority
2	Life would promote the growth of these recognized organizations by eliminating the need to go
3	through the ASUN recognition process that requires verification of seven (7) members;
4	Whereas, these organizations current membership is made up of students from underrepresented
5	and minority-based backgrounds that may struggle with recruitment and recognition due to the lack
6	of funding;
7	Whereas, according to No Walls 2025: A Student Vision for the University of Nevada, the
8	campus will have "gained a greater understanding for people different than themselves;" 1
9	Whereas, the 87th Session of the Senate has made the promotion of Diversity, Equity, and
10	Inclusion a legislative priority;
11	Whereas, access to funding will help these organizations acquire more members and conduct
12	efficient requirement practices;
13	Whereas, according to ASUN officials within the Department of Clubs and Organizations,
14	currently Club Sports require the most funding and advising in order to conduct their mission and
15	business;
16	Whereas, at other higher education institutions, clubs centered around recreational sports and
17	fitness are usually recognized and operated by the Department of Fitness and Recreational Sports;
18	Whereas, in order to give Club Sports the required support they need in order to be successful,
19	Club Sports will eventually transition under the purview of the Department of Fitness and
20	Recreation;
21	Whereas, in order to increase collaboration and assist with the transition of Club Sports to the
22	Department of Fitness and Recreation, the Department of Fitness and Recreation should handle the
23	process of recognizing clubs that have to do with fitness and recreation;

S. R. 87-A RESOLUTION AGAINST ANTI-SEMITISM ON CAMPUS AND IN NEVADA

IN THE SENATE OF THE ASSOCIATED STUDENTS MARCH 2^{ND} , 2020SUBMITTED BY SENATOR SUPPLE TO THE COMMITTEE ON PUBLIC AFFAIRS A Resolution Against Anti-Semitism on Campus

1	Whereas, anti-Semitism is defined as "a certain perception of Jews, which may be expressed as
2	hatred toward Jews. Rhetorical and physical manifestations of anti-Semitism are directed toward
3	Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and
4	religious facilities"1;
5	Whereas, there are reports of at least sixteen (16) anti-semitic acts on campus in the 2019-2020
6	academic year at the University of Nevada, Reno. Such incidents include drawing swastikas or writing
7	anti-Semitic messages;
8	Whereas, after the 1900's, the swastika has been a symbol of the Nazi Party in Germany that
9	orchestrated the deaths of over six million (6,000,000) Jews and continues to invoke "terror into Jews

1	and others deemed enemies of Nazi Germany"2 included homosexuals, citizens of the Soviet Union,
2	prisoners of war, Serbians, people with disabilities, Romani, Jehovah's Witnesses, etc.;
3	Whereas, Hillel of Northern Nevada is a group of Jewish students on our campus and across
4	other campuses of Northern Nevada that aim to make campus a safe place for Jewish students away
5	from home;
6	Whereas, Jacky Rosen, Senator for the state of Nevada, released a statement against anti-
7	Semitism in the state of Nevada and in the United States ³ ;
8	Whereas, anti-Semitism is not disappearing in the United States with 1,879 anti-semitic acts
9	reported in 2018 and an increase in physical violence towards Jewish people, Jewish schools,
10	synagogues, and on college campuses ⁴ ;
11	Whereas, the University of Nevada, Reno Campus Climate Survey recorded that 71% of the
12	population feels comfortable on campus. However, it is also recorded that minorities feel less
13	comfortable than other groups on campus, making up the other 29% of the student population ⁵ ;
14	Whereas, there are no known anti-semitic groups present on campus, but rather it is assumed
15	that there are individual students who have been committing acts of anti-Semitism on campus;
16	Whereas, in 2019, the University of Nevada was named as one of the top universities of "Neo-
17	Nazi Incidents"6;
18	Whereas, safety, diversity, equity, and inclusion were deemed legislative priorities for the 87th
19	session of the Associated Students of the University of Nevada;
20	Whereas, Jewish students do not feel safe with reoccurring incidents of anti-Semitism on
21	campus;
