A Bill

An Act to Move Funds from the Welcome Week Concert Account to the Programming Board Account

1 *Whereas*, the newly branded, Welcome Week Concert, has met and exceeded the revenue line set
2 out for fiscal year 2020;

3 *Whereas*, the Programming Board is responsible for all administrative procedures and duties
4 relating to the Welcome Week Concert account;

5 *Whereas*, the funds remaining in the Welcome Week Concert account will remain stagnant until
6 transferred into an active ASUN account;

7 *Whereas*, the funds transferred from the Welcome Week Concert account will be allocated
8 toward the Spring Concert;

9 *Be it enacted*, \$3,829.38 be transferred from the Welcome Week Concert account (PG03085) to
10 the operating line in the Programming Board account (PG05175).
