Senator Yang presented the legislation. She said they wrote this resolution because it has been the top requested feedback from students. She mentioned President Hall's petition for pass/fail grading with over 2,000 signatures.

Senator Yang said she spoke to them about why students want this and spoke to other administrators and got their insight on why administration and faculty may be against it.

Senator Abrams asked if they can vote on this legislation if they are an author.

Senator Stoddard said yes.

Senator Harvey said yes, all the authors can vote except Senator Stoddard.

The body moved into a vote to approve S. R. 88 - A Resolution in Support of Satisfactory/Unsatisfactory Grading.
