A BILL

AN ACT MOVING FUNDS TO THE SENATE BUDGET

- 1 *Whereas*, per S.B. 88- An Act to Amend the Budget for Fiscal Year 2021 to Reflect Budget
2 Changes¹ removed all funds from the ASUN Senate Host account;
3 *Whereas*, the Senate of the Associated Students wishes to use funds for host;
4 *Be it enacted*, \$100 be transferred from the reserves line in the Budget and Finance account
5 (PG05837) to the Senate Meetings/Trainings line in the ASUN Senate Account (PG01395).
