 - Senator-Elect Thompson accepted the nomination.

b. Nominee Presentations

• Senator-Elect Noble delivered a presentation to the body.

• Questions:

- Senator-Elect Bergren asked Senator-Elect Noble to elaborate on his plans to conduct qualitative research as part of his student outreach. Senator-Elect Noble replied that he would request summaries from each Senator regarding what they learned from their outreach hours.
- Senator-Elect Ngo asked Senator-Elect Noble if he viewed his involvement with state politics as a conflict of interest with his involvement with the Association. Senator-Elect Noble replied that his involvement with state politics gave him the skills to enforce professionalism and robust dialogue as Speaker. He vowed to keep his own personal biases in check as Speaker.
- Senator-Elect Thompson delivered a presentation to the body.

• Questions:

- Senator-Elect Salah asked Senator-Elect Thompson how he planned to increase Senator retention in the upcoming session. Senator-Elect Thompson responded that he planned to use more foundational training and open conversations to help Senators feel safe expressing doubts and overcoming obstacles in their roles.
- Senator-Elect Ngo asked Senator-Elect Thompson how he planned to fill in his own gaps in knowledge if he were to be elected Speaker. Senator-Elect Thompson answered that he planned to collaborate with experienced professional staff and with the Parliamentarian and Speaker Pro Tempore in order to keep up with the learning curve in his new role.

• Deliberations:

- Senator-Elect Bergren endorsed Senator-Elect Thompson on the basis of his
 ongoing involvement and interest in the Association, even during the height of the
 pandemic when participation in student affairs was difficult. She commended his
 consistency and transparency in each of his initiatives during his time as a senator.
- Senator-Elect Ngo commended Senator-Elect Thompson's experience and professionalism within the Association. She also highlighted Senator-Elect Noble's relevant experience and passion for legislation. She suggested that he would be better suited to a role that would allow him to continue passing resolutions in the 90th Session.
