3. PUBLIC COMMENT

a. ASUN Speaker Pro Tempore, Olivia Ngo

 Speaker Pro Tempore Ngo spoke in support of amending S.B. 90 – A Bill to Ensure Public Access to Senate Meetings, and S.B.R. 90 – A Binding Resolution to Ensure Public Access to Senate Meetings. She primarily voiced concerns about publishing meeting links directly on meeting agendas, citing past incidents of Zoom bombings during public meetings.

b. ASUN Chief Justice, Zane Taylor

• Senator Salah read a written statement from Chief Justice Taylor about Nevada's student loan legislation. The statement also included remarks in support of S.B. 90 – An Act Revising Election Punitive Processes.

 - Senator Galvez presented on the legislation, a revised version of the one previously failed at Committee. He stated that the new version required Senators who wanted to attend through Zoom to receive permission from the Speaker of the Senate beforehand.
 - Senator Galvez addressed Speaker Pro Tempore Ngo's public comment about Zoom link security, as well as a question from Senator Swackhamer regarding the necessity of the legislation.
 - Vote: 2 in favor, 0 against, 0 abstained.
