# A Resolution to Promote Equity, Inclusion, and Integrity in the School of Social Work

Whereas, Bachelor's level social work students are required to put in 225 hours at an unpaid
 internship per the graduation requirements;
 Whereas, the School of Social Work introduced a new class curriculum for SW 427: Social Work
 Methods with Organizations, Communities, and Legislatures in the Spring semester of 2024 with an
 additional 75 hour time log requirement – increasing our total hours from 225 to 300;

1	Whereas, the class material for SW 427 revolves around campaigning for a social issue, which is
2	not a feasible task within a single semester, and would more beneficial to have earlier in the social
3	work educational path;
4	Whereas, the School of Social Work did not adequately communicate the time log requirement
5	until February 16, 2024, a month into the semester, leaving many social work students trying to catch
6	up to meet class requirements;
7	Whereas, split-year students who are graduating in Spring 2024 with the full-time students, and
8	already completed the SW 427 class did not have the additional requirement of 75 hours added to
9	their workload;
10	Whereas, the Bachelor of Social Work Program introduces a data analysis class for senior-year
11	social work students, despite not having a math requirement in years;
12	Whereas, the increase in the workload of the final semester of the Bachelor of Social Work
13	Program at UNR has caused intense stress among students;
14	Whereas, hybrid students are required to submit all assignments on the same day as their 8-hour
15	class, often leaving them with little time for questions or concerns;
16	Whereas, when students brought their concerns to their professors, the response from the
17	School of Social Work was simply that we would "get through it", rather than offering any kind of
18	help or change to the curriculum that was thrown on the students this semester;
19	Whereas, non-traditional students often do not have the time or privilege of dedicating the extra
20	hours to their classes due to working full-time jobs to support themselves, pay bills, and pay for
21	college;
22	Whereas, social work students paid and applied to get into the Bachelor of Social Work Program
23	only for the School of Social Work to change their curriculum and not adequately communicate the
24	changes to students who are applying to the program;

1	Whereas, the School of Social Work students feel a great amount of disrespect from the
2	University and from the School of Social Work due to their lack of communication and their
3	dismissal of student voices, views, opinions, and circumstances;
4	Whereas, the structure of the School of Social Work does not promote inclusivity of non-
5	traditional, hybrid, split-year, or neurodiverse students as evident by their demands with hours, due
6	dates, and class requirements which do not take into account the personal circumstances of students;
7	Whereas, the School of Social Work does not acknowledge the privilege that comes with being a
8	full-time student, and often puts all non-traditional students at a great disadvantage;
9	Whereas, the School of Social Work students have not had a consistent and reliable advisor to
10	turn to when facing issues within the program;
11	Whereas, the School of Social Work has demonstrated a pattern of inadequate communication
12	with its students, faculty, and staff, resulting in misunderstandings, delays, and frustration among
13	school of social work students;
14	Whereas, integrity as the act of responsibly promoting ethical practices on the part of the
15	organization is a foundational ethical principle for the National Association of Social Workers
16	(NASW) and in the Code of Ethics Social Work students are to follow; <sup>1</sup>
17	Whereas, under the Integrity of the Profession in our NASW Code of Ethics, social workers
18	should "uphold and advance the values, ethics, knowledge, and mission of the profession," and,
19	"protect, enhance, and improve the integrity of the profession.";2
20	Whereas, in accordance with our Code of Ethics, Social Workers are expected to engage in and
21	support, "social and political action that seeks to ensure that all people have equal access to

4	accommodate the needs of non-traditional and diverse students to ensure equitable access, support,
5	and success for all social work students;
6	Be it further resolved, the School of Social Work must revise its communication standards in
7	compliance with our Code of Ethics to enhance the integrity of the program and to prevent future
8	miscommunication and confusion. It is imperative that these changes be made to ensure that future
9	cohorts are not led down by the School of Social Work;

# A Resolution to Add an Undocumented Student Programs Liaison Position to the Committee of IDEA

Whereas, the Trump administration enacted the suspension of DACA and the Biden administration has denied accepting new applications, the incoming class of 2024 will no longer have the option to apply for DACA;

Whereas, this policy change means that undocumented students are now unable to apply for protection against deportation and consequently face new financial, academic, and legal barriers;

Whereas, the Manager of Undocumented Student Programs, Janet Najera, has stated that this policy change will create a rise in undocumented students and expressed interest in having a senator from the senate body serve as an official liaison between ASUN and the Undocumented Student Programs to support its students and their advocacy efforts;

Whereas, the Undocumented Student Programs serves as a resource and safe space to all DACA undocumented, and mixed status students at the University of Nevada, Reno;

Whereas, the ASUN Senate Committee of IDEA does not currently have listed a liaison position to represent the Undocumented Student Programs;

Whereas, the Chair of the Senate Committee on IDEA Ali and Senator Landazuri have expressed interest in creating a liaison position between senate and the undocumented students program;

Be it resolved that, the Senate committee on IDEA add an undocumented student programs liaison position to its committee effective immediately;

#### Addendum B

#### Rule II: MEMBERSHIP OF THE SENATE

#### f) ATTENDANCE AND ACCOUNTABILITY 91ST SESSION RULES OF THE SENATE

- 1) No Senator shall be absent from the service of the Senate without leave.
- 2) The Committee on Oversight shall conduct a hearing on the senator's attendance on the 5th accumulated point (refer to Rule II, (f), 4, (i-v)) in which the senator shall be afforded an opportunity to present either oral or written testimony defending or admitting to his, her, or their absences. The committee shall determine if the absences merit the imposition of disciplinary action against the senator. During the hearing, the Committee on Oversight has the authority to excuse or dismiss points compiled against a senator if there is reasonable explanation.
- 3) Upon verifying the fifth accumulated attendance point, the Committee on Oversight shall recommend a censure of the offending senator. Any senator's first censure shall include, at minimum, a recommendation that the senator in question release a public statement or apology to the Nevada Sagebrush. Additional punitive action, which may include expulsion from the Senate, will be recommended upon the accumulation of additional points.
- 4) The Attorney General will have the power to file charges against the Speaker of the Senate upon the accumulation of the fifth point.
- 5) Reports of Attendance and Absence as well as respective points gained toward censure will be reported by the Secretary of the Senate during each Oversight Committee meeting of the Senate of the Associated Students and consolidated by the Speaker of the Senate. The Senate shall calculate attendance upon the following point formula:

- i) Six unexcused absent Senate outreach hours shall be equivalent to two points. (1/3 point for every missed hour)
- ii) An unexcused absence from a Committee of the Senate shall be the equivalent to one point.
- iii) Three instances of unexcused tardiness at committee meetings shall be equivalent to one point. (1/3 point for every instance)
- iv) Three instances of unexcused tardiness at general senate meetings shall be equivalent to two points. (2/3 point for every instance)
- v) An unexcused absence from a meeting of the Senate of the Associated Students shall be equivalent to two points. vi.)
- vi) Three instances of failure to meet with an assigned intern shall be the equivalent of 1 point (1/3 point for every missed hour).
- vii) Failure of Chairpersons or Vice-Chairpersons to report before the Senate shall be the equivalent to one point against the name of the respective Chairperson.
- viii) Failure of the Speaker of the Senate to report the consolidated reports to the Nevada Sagebrush and the Legislative Clerk shall be the equivalent of two points.
- ix) The Secretary will send an electronic report of the points accumulated by the Speaker of the Senate, as detailed under Rule II, (f), 4, (ix) to the Attorney General.
- x) Failure of the Chairperson of a committee, including the Committee on Oversight, to hold a meeting within the required two-week period shall be the equivalent of two points.
- 6) Failure of Senators to update the legislative tracker at the end of each outreach period will result in the accumulation of one 1/3 of a point at the discretion of the Parliamentarian.

#### **Rule XX: SENATE OFFICERS**

a) PARLIAMENTARIAN The Speaker shall appoint from the membership of the Senate a Parliamentarian, subject to the majority approval of the Senate, who shall advise the Speaker and individual Senators on matters of Senate Procedure, the law, and the Constitution. In addition, they shall be responsible for the publicization of the Legislative tracker and ensure it is up to date.

#### TITLE I: THE LEGISLATIVE BRANCH

#### **CHAPTER 101: COMPOSITION**

#### **SECTION 07: PARLIAMENTARIAN**

#### a) IN GENERAL:

The Speaker shall appoint from the membership of the Senate a Parliamentarian, subject to the majority approval of the Senate, who shall advise the Speaker and individual Senators on matters of Senate procedure, the law, and the Constitution of the Associated Students.

#### b) DUTIES:

- 1) The Parliamentarian shall be informally trained along with or by the Attorney

  General of the Association within 14 days of assuming office and shall informally

  train officers and department directors on parliamentarian procedures.
- 2) Assume a voting position within the Committee of Oversight and the Committee on Government Operations.
- 3) Advise the Speaker and individual Senators on matters of Senate Procedure, the law, and the Constitution.
- 4) Be responsible for the publicization of the Legislative tracker and ensure it is up to date.
