- b. S.B. 93 An Act to Approve the Budget for Fiscal Year 2026
- - President presented FY 2026 budget proposal.
- - Key points:
- • Budget began in deficit; over \$200,000 in cuts made.
- • Causes: declining enrollment, depletion of COVID-era surpluses, return to standard ASUN budget constraints.
- • Cuts distributed across areas to minimize impact.
- • Consultations held with department directors and stakeholders.
- • Rollover from canceled ASUN concert cushioned some reductions.
- • Notable Adjustments:
- - 7% operational cut to Student Media.
- - Milton Glick Initiatives funded at FY24 start levels.
- - Government Affairs reduced due to non-election, non-legislative year.
- - Clubs & Orgs funding increased by \$27,000 (total \$200,000).
- - Emphasis placed on stretching dollars further, staying mission-oriented, and supporting students despite challenges.
