# A BILL TO REEXAMINE THE ROLE OF ATTORNEY GENERAL

In the Senate of the Associated Students

April 24th, 2025

Submitted to the Senate of the Associated Students by Speaker Pro Tempore Moss and Parliamentarian Issa, on behalf of President Aglubat and Vice President McNamara

Whereas, the Associated Students of the University of Nevada (ASUN) maintains an Office of the Attorney General, which currently serves as a non-legal position responsible for upholding the ethical integrity of the Association;

Whereas, under Nevada Revised Statutes (NRS) 7.285, it is unlawful for any person to engage in the practice of law, including providing legal advice or legal representation, without being a licensed attorney admitted to the State Bar of Nevada;

Whereas, the title of "Attorney General" implies a legal authority or capacity that student leaders in ASUN do not possess, as they are not licensed attorneys and are therefore legally prohibited from giving legal advice or opinions on behalf of the Association:

Whereas, ASUN has a responsibility to uphold transparency, accountability, and compliance with all applicable laws and to ensure that all titles and responsibilities within the Association reflect the legal and ethical limitations of student government; and

Whereas, renaming the position of Attorney General to "Director of Ethics and Compliance" more accurately reflects the non-legal, oversight-based functions of the role, including ensuring ASUN's operations remain in accordance with governing documents and ethical standards.

*Be it enacted,* that the Secretaries of the Senate shall examine the Statutes of the Associated Students and strike any and all mention of the title "Attorney General" and replace it with the title of "Director of Ethics and Compliance";

*Be it further enacted*, that the changes outlined in Addendum A shall be adopted into the Statutes of the Associated Students:

### Addendum A

#### CHAPTER 205: ATTORNEY GENERAL

#### SECTION 01: ESTABLISHMENT

There is hereby an Attorney General, appointed by the President, with the consent of the Senate.

#### **Section 02: Duties**

The duties of the Attorney General are:

- 1) The Attorney General shall issue advisory opinions concerning the law, legislation, or any other act of the Association.
- 2) Copies of the Attorney General's opinions will be distributed to the President, Vice President, and all Senators. The opinions are to also be made available to anyone upon request.
- 3) All requests for the Attorney General to issue advisory opinions must be made in writing except those made on the Senate floor.
- 4) To update and distribute the Constitution for the purpose of engrossing any Constitutional Amendments as passed by the Association and approved by the Board of Regents. The Attorney General is designated the responsibility to publish current editions of the Associated Student's Constitution.
- 5) The Attorney General shall act as President if, by reason of death, resignation, removal from office, inability, or failure to qualify, there is no President, Vice President, Speaker of the Senate, Director of Clubs and Organizations, or Director of Programming to act as President.
- 6) The Attorney General shall investigate alleged violations of the Election Code and prosecute offenders before the Judicial Council.
- 7) The Attorney General shall prosecute any case, at the Attorney General's or Judicial Council's discretion, filed by a third party, even in cases where the plaintiff seeks to dismiss the charge.
- 8) The Attorney General shall act as the representative of the Director of Elections and Democratic Education before the ASUN Judicial Council.
- 9) The Attorney General shall ensure that all regulations concerning petitions are followed fully.
- 10) The Attorney General shall deliver and provide for all petitions (for each election) or for initiative and referendums to the President of the Associated Students and the Director of Elections and Democratic before the Candidates' Meeting.
- 11) The Attorney General shall assist any student interested in writing a petition for initiative and referendum.
- 12) The Attorney General shall certify that a petition question is an impartial and accurate description of the proposal and shall assign the petition an Official Name and Number, if the petition creates a law, prepare an Official Summary of the petition, to confer with the office of Legal Counsel or designee for approval of language on questions of student fees, and to create the petition and return to the Primary Proponent three (3) copies of the petition.

- 13) The Attorney General shall verify that there are a sufficient number of valid signatures on each petition, by checking the student status of each person who signed the petition, to immediately notify the Primary Proponent(s) if the verifying official discovers that the petition submitted lacks sufficient valid signatures, and to preserve the petition for the same time period as the Director of Elections and Democratic Education preserves the ballots for the election for which the petition qualified or attempted to qualify for placement on the ballot.
- 14) The Attorney General shall notify Candidates and all others cited of charges during elections.
- 15) The Attorney General shall supervise ballot tabulation.
- 16) The Attorney General shall release the election results as soon as possible. 17) The Attorney General shall attend or send a representative to all physical polling locations and places where ballots are kept and tabulated, provided such representative is not a candidate or agent in the election.
- 18) To carry out such other functions and duties as required under the constitution and laws.
- 19) The Attorney General shall not prosecute any case to which the Attorney General is a party or in which the Attorney General has an interest in the outcome as described in subsection 3, Title III, Chapter 302, Rule 3a. When such a conflict occurs, the Chair of Government Operations shall act as a special prosecutor to act as and perform the elections duties of the Attorney General insofar as the Attorney General's conflict is concerned.
- 20) To have a report read or spoken into record at minimum every other Senate meeting. 21) Responsible to attend all ASUN retreats, and training as decided by the President and the Director of Executive Outreach.
- 22) The Attorney General shall serve as ex-officio member on the Senate Committee on Government Operations.
- Organize trainings and continue to provide education on Nevada Open Meeting Law for the Association.
- 24) Ensure Nevada Open Meeting Law is followed and work with Officers to correct any violations.
  - a) To cancel meetings that have violated Nevada Open Meeting Law.
  - b) In the cancellation notice, the Attorney General must list what violation(s) occurred.
  - c) The Attorney General must send a meeting cancellation notice no later than twenty-four hours before the meeting is to take place.
- The cancellation notice must be sent to the presiding officer and Secretary of the Senate. 26) To invalidate meetings that have been conducted and violated Nevada Open Meeting Law.
  - a) In the invalidation notice, the Attorney General must list the violation(s) that occurred.
  - b) The invalidation notice must be sent to the presiding officer and the Secretary of the Senate.
  - c) Ensure that Executive Department Heads are hosting regular meetings in accordance with Nevada Open Meeting Law at least once per month.

# A BILL TO REFORM THE ANNUAL ASUN RETREAT

IN THE SENATE OF THE ASSOCIATED STUDENTS

APRIL 24TH, 2025

SPONSORED BY SPEAKER PRO TEMPORE MOSS

Co-Sponsored by Parliamentarian Issa and Senator Miceli

Originally authored by Speaker Acklin and Senator Lawler

**Whereas**, the Associated Students of the University of Nevada, Reno (ASUN) organizes an annual retreat designed to orient new members about the organization, promote leadership development, and strengthen relationships among other ASUN officers;

Whereas, this retreat serves as a vital opportunity for new ASUN members to engage in team-building activities, and gain insights into the organization's mission and goals, ultimately preparing them for effective participation in student governance;

Whereas, in FY24, ASUN's revenue allocation represented 0.44% of the university's total revenue, while its budget allocation was 0.37% of the university's total budget, demonstrating ASUN's prudent fiscal management and its capacity to allocate resources efficiently in service of student needs;

Whereas, to ensure accountability and transparency with the student body, the ASUN President shall be allowed to allocate <u>up to</u> 1% of ASUN's annual budget each year specifically for the retreat, thereby underscoring the organization's commitment to fostering leadership and collaboration;

Whereas, if the President had decided to go past this 1% stopgap, they would have to go through the Senate Body to advocate for a change the percentage since it would be binding in the SAS.

**Whereas**, this budget allocation will facilitate planning and coordination for the Director of Events and the President, streamlining the organization of this essential event;

**Whereas**, Beginning in June 2024, the Associated Students of the University of Nevada (ASUN) hosted its annual retreat at the University of Nevada, Lake Tahoe campus;

Whereas, to establish a precedent of fiscal responsibility and to continue fostering engagement with the Lake Tahoe campus community, it would be in the Association's best interest to plan future annual retreats at the University of Nevada, Lake Tahoe campus;

Whereas, while there is currently no binding policy preventing the ASUN President and Director of Executive Outreach from selecting a private venue for future retreats, such decisions remain at their discretion;

Whereas, selecting a private institution for the retreat would likely introduce unnecessary complications, including increased costs, logistical challenges related to transportation, and additional administrative hurdles, all of which could be avoided by utilizing the University's own Lake Tahoe campus facilities;

Whereas, by securing dedicated resources, ASUN officers can focus on the retreat's agenda, engage meaningfully with attendees, and create a supportive atmosphere, rather than being bogged down by logistical coordination with a private institution or the Lake Tahoe campus;

Whereas, ASUN will establish a contract with Lake Tahoe UNR, ensuring that starting in June of 2025, the retreat will be held at this campus every three years on the second weekend of June, providing a consistent and conducive environment for learning and bonding;

Whereas, the retreat will include required presentations from the following ASUN entities: The Senate of the Associated Students; Executive Branch: President of the ASUN; Vice President of the ASUN; Attorney General; Department of Campus and Public Relations; Department of Campus Wellness; Department of Clubs and Organizations; Department of Executive Affairs; Department of Executive Outreach; Department of Government Affairs; Department of IDEA; Department of Programming; Department of Sustainability; The Judicial Council of the ASUN; Pack Rides; Legal Services; Pack Provisions;

Be it enacted by the Senate of the Associated Students, shall create a way to make the Annual ASUN Retreat more manageable and successful. ASUN shall be allowed to allocate up to 1% of its annual

budget each fiscal year to fund the ASUN Retreat, ensuring financial accountability and transparency to the student body. The ASUN President and the Director of Events shall oversee the planning and coordination of the retreat to ensure streamlined organization and effective use of resources. The retreat agenda shall include required presentations from ASUN entities to facilitate leadership development, governance training, and interdepartmental collaboration. These entities include the Senate of the Associated Students, the Executive Branch (President, Vice President, Attorney General, and all departments), the Judicial Council, Pack Rides, Legal Services, and Pack Provisions. ASUN shall ensure that the retreat remains focused on leadership development, student advocacy, and effective governance. By securing dedicated resources and a structured venue, ASUN officers can engage meaningfully with attendees and strengthen collaboration across departments without being burdened by logistical challenges.

- b. There would be no binding policy preventing the ASUN President and Director of Executive Outreach from selecting a private venue for future retreats, such decisions remain at their discretion, due to logistics and contractual law.

Whereas, student veterans have demonstrated remarkable dedication, resilience, and commitment to both their academic pursuits and their service to our country;

Whereas, student veterans contribute significantly to the diversity, leadership, and academic excellence of the University of Nevada, Reno (UNR) community, bringing unique perspectives and life experiences that enrich campus life;

Whereas, student veterans often face unique challenges in balancing their academic responsibilities with the transition from military to civilian life, and these challenges deserve recognition and support from the university community;

**Whereas**, creating a designated day of gratitude will foster a greater understanding and appreciation of the sacrifices and contributions made by student veterans among the entire student body, faculty, and staff at UNR;

Whereas, Veteran Services will collaborate with ASUN and the Public Relations department to promote the "Day of Gratitude for Student Veterans," utilizing this day as an opportunity to host a tabling event. This event will raise awareness about veteran services and provide students with a greater understanding of the student veterans who have served our country.

Whereas, the first Monday of November is a meaningful date for UNR to annually observe and celebrate the accomplishments and service of student veterans in a special manner;

**Be it enacted,** that the Associated Students of the University of Nevada shall draft a bill to officially recognize the first Monday of November each year as the "Day of Gratitude for Student Veterans." This day will honor the service, contributions, and experiences of student veterans at the University of Nevada, Reno, and will include events, activities, and acknowledgments to celebrate their unique role within the university community.

#### c) COMMITTEE ON DEMOCRATIC CIVIC ENGAGEMENT

The Committee on Democratic Civic Engagement shall be responsible for promoting civic engagement to the students, faculty, and administration of the university as well as the Reno community. The Committee shall be responsible for formulating policies regarding bodies of governance at the local, state, and federal levels, including the Reno City Council, the Nevada System of Higher Education Board of Regents, and the Nevada State Legislature. The committee shall voice student concerns regarding the tuition and fees of the university while collaborating with the Student Fee Committee to report on student fee increases or decreases and provide updates on the progress of all student fee changes. The committee shall be responsible for working with the Center of Student Engagement Professional Staff on democratic and civic engagement initiatives such as GivePulse and the Silver Paw Award. The Committee on Democratic Civic Engagement shall support academic courses that endorse activism in the local and national community. The committee shall outreach to local non-profits to provide opportunities for students to serve in the community. The committee shall be responsible for planning the annual Veterans' lunch along with "Day of Gratitude for Student Veterans at the University of Nevada, Reno" being the first Monday of November, and paying tribute in honor of 9/11. #### Addendum A

#### Rule XII: COMMITTEE PROCEDURE

#### g) LIASON CONTACT PROCEDURE

- 1) Senators shall have email or face-to-face contact at least once every two weeks and shall meet monthly to discuss projects or issues pertaining to the liaison contact.
- 2) Senators shall offer to Committee a report, either spoken or written, on their liaison meetings no less than once a month. Reports should include information on official activities and progress since the previous meeting and any announcements the Senator deems necessary.
- 3) Upon removal from a liaison position, Senators shall compile general information of their work with the liaison contact, including ongoing projects, issues, or legislation that is being written.
- 4) Upon removal from a liaison position while in session or recess, the removed Senator shall establish contact between the liaison contact and the new Senator in that position. This may be done face-to-face or by email. 5) Upon removal from liaison positions due to the adjournment of a session, Senators shall compile general information of their work with the liaison contact, including ongoing projects, issues, legislation that may be being written, and contact information, and submit it to the Committee Chair.
- 6) Committee Chairs shall coordinate with the Speaker Pro-Tempore to have this information included in the Senate Legacy Box (see SAS Chapter 101 Section 07.b.11).
- 7) In the event that a liaison position stands empty, the Committee Chair of the affected committee shall announce the empty position(s) in their committee report to encourage Senators to join and fill the empty positions. Empty positions should be continued to be announced in the report until they are filled.
- 8) In the event that a liaison position stands empty after two consecutive Senate meetings, the Committee Chair shall request Committee members to add themselves to that liaison position. If no Senators add themselves, the Vice-Chair and Chair shall add themselves to empty liaison positions, alternating as they open.
