7. NEW BUSINESS

-The following pieces of business were discussed:

- a. Review rules and reasonability's of the committee-** Speaker Acklin gave a informational overview regarding what the committee will look at and the appropriate processes thereof. Added that committee will be reviewing expulsion process of senators that will be new to the committee.

- b. Goals for individual committees from all Chairs-**

-Senator Levy- Expressed wanting to help Exec branch with “Safety Week” and noted the positive relation between her committee and the Department of Sustainability and wants to work with sustainability department for facilities to proper recycling (will work out details later). -Chair Levy mentioned the positive impacts of Senators McAndrews, Villa, and Barrus.
