Senator Houghtelling of the School of Public Health was nominated by Senator Levy and Senator Nicholas Bohlander of the College of Business was nominated by Parliamentarian Issa. Each accepted their nomination.

Senator Houghtelling presented first. Senator Houghtelling emphasized his previous experience and the need for clear procedures, expectations and accountability within the committee and the goal of executing the ASUN SAS Audit.

Senator Barrus asked Senator Houghtelling about his experience and how it prepared him to be chair.

Senator Bohlander presented next. Senator Bolander presented a detailed timeline for completing the SAS audit, discussed his leadership style, and stressed the importance of committee engagement and transparency during the session.

Senator Barrus asked Senator Bohlander about his experience and how it prepared him to be chair.

During the Senate debate, multiple senators weighed the strengths of both candidates—Senator Houghtelling and Senator Bolander—but ultimately favored Bolander for his committee-specific focus, structured planning, and collaborative leadership style. Senator Houghtelling was acknowledged for his prior experience as a chair and vice chair, and for his intent to continue former Chair Terry's initiatives. However, concerns were raised about the generality of his goals, which some felt were more appropriate for broader ASUN reform than for the Government Operations Committee. Senator Castro pointed out that Houghtelling's presentation echoed ideas from his previous campaign for Speaker and lacked specificity tied to the committee's unique functions. Senator Lucchesi expressed disappointment in Houghtelling's comment that committee chairs often fail to follow through, arguing that such remarks unfairly diminished the work of past chairs. In contrast, Bolander was praised for his detailed SAS audit timeline, active involvement in committee work, and zero attendance points—compared to Houghtelling's two points for unexcused absences. Senator Miceli voiced concern that Houghtelling's desire to standardize committee operations could suppress creativity, while Bolander's authenticity and openness to feedback were seen as key leadership traits. Senator Lawson highlighted Bolander's contributions to reviewing Title 4 and 5, particularly his ideas for reforming ASUN compensation structures. Several senators, including those who worked with Bolander in WIFC and on the audit, endorsed him for his reliability, humility, and readiness to lead. Parliamentary dissent reinforced the view that Houghtelling's goals could be pursued as a senator without needing the chair position, while Bolander's inclusive leadership style was described as a model for ASUN and beyond. The debate concluded with a roll call vote, where Bolander was elected Chair of Government Operations.

Senator Bolander was elected Chair of Government Operations by a unanimous roll call vote of 17–0.

Motion to approve the appointment by Speaker Pro Tempore Moss, seconded by Parliamentarian Issa. Motion carried.
