# 1. CALL MEETING TO ORDER

# 7. REPORTS OF ASUN OFFICERS (INFORMATION ONLY)

**a.** President of the Associated Students - **Carmina Aglubat**- Reported on announcing the postponement of the Welcome Week concert to the spring semester. She explained that this

- decision was made to allow for more strategic planning and collaboration with the Athletics Department. She followed with a passionate address to the Senate, emphasizing the importance of leadership, transparency, and legacy within ASUN. Her remarks encouraged senators to reflect on their roles and the impact they can make during their term.
- b. Vice President of the Associated Students Ethan McNamara- reported that orientation sessions had concluded successfully and that the Block Party volunteer form had been distributed. He also shared that the Pack friendly business program is expanding, aiming to connect students with local businesses offering student discounts and benefits.
- c. Chief Justice Rena Arneson- No report at this time.
- **d.** Director of Executive Outreach **Naomi Tecson-** provided updates on Block Party planning and logistics. She announced a makeup retreat scheduled for September 20th for those who missed the original date and mentioned an upcoming meeting with the City of Reno to explore partnerships that support student engagement with local businesses.
- **e.** Director of Executive Affairs **Gabriella Detrick** reported a significant increase in internship applications and student interest. She announced a new collaboration with the First Gen Center to support first-generation college students and shared that ASUN-branded polos and name tags had been ordered for internal use.
- **f.** Director of Clubs and Organizations **Madison Hess-** discussed ongoing preparations for Club Renewal and the Fall Club Fair. She confirmed that commissioner training had been completed and noted that funding changes had been communicated to clubs to ensure transparency and compliance.
- **g.** Director of Programming **Railyn Krentz-** reiterated the concert postponement and emphasized the importance of strategic timing. She announced that the final event programmer had been nominated and shared that Welcome Week planning was nearly finalized, with events scheduled and logistics in place.
- h. Director of Government Affairs Kennedy Taylor- reported that her team is planning a week of civic engagement events for the second week of the semester. She is collaborating with the Office of Government & Community Engagement on student advocacy and monitoring federal policy changes that may impact students.
- i. Director of IDEA **Zyna Navarte** shared that preparations are underway for ASUN's presence at Northern Nevada Pride and invited senators to participate and represent ASUN at the event.
- j. Director of Sustainability Sephora Lee- reported ongoing outreach for the Farmer's Market and shared that she is collaborating with IDEA and other departments to integrate sustainability into campus programming.
- **k.** Director of Campus and Public Relations **Juliauna Sullivan-** announced that Welcome Week marketing materials had been finalized. She is preparing an Instagram post to promote open Senate seats and has drafted a public statement regarding the ASUN concert postponement.
- 1. Director of Campus Wellness Emily Hohman- submitted a written report outlining plans for Safety Week, which will include partnerships with UNRPD, NV Cares, and Counseling Services. She also confirmed her participation in the Mental Health Task Force, which focuses on student well-being initiatives.
- m. Director of Ethics and Compliance Caleb Oster- No report at the time.
- n. Speaker of the Senate Leaf Acklin- announced that the Oversight Committee will meet on August 11th. He shared that Senate candidate presentations are scheduled for August 20, 27, and September 3, and that workshops on Robert's Rules and legislation will be held on August 27 and September 10. He also confirmed that the Senate will not meet on August 13th.

- **g.** Special Committee on Food Insecurity **Alexander Saporito-** reported that liaison roles have been assigned to committee members and that preparations are underway for fall programming focused on student food access and support.
- **h.** Parliamentarian **Jason Issa-** shared that he is developing an outline for a Robert's Rules workshop, aiming to improve legislative fluency and procedural confidence among senators.
  - i. Speaker Pro-Tempore **Dillon Moss-** reported that the internship syllabus for Senate interns is nearly finalized and that materials for training and onboarding are being prepared and reiterated to help with block party.
  - **j.** Committee on Oversight **Leaf Acklin-** announced that a meeting has been scheduled on Aug. 11<sup>th</sup> at 1:30 pm to review potential censures of 2 senators and accountability measures. The committee will address Senate attendance and conduct concerns.

# 17. SECOND READING OF LEGISLATION (FOR POSSIBLE ACTION)

The following bills and resolutions will receive their second reading and may be considered:

a. S.B. 93 - An Act to Establish ASUN Standard Meeting Procedures

Agenda item 17A concerned Senate Bill 93, titled "An Act to Establish ASUN Standard Meeting Procedures." Speaker Pro Tempore Moss opened the presentation by explaining the bill's intent: to formalize a set of procedures and protocols that would guide chairs, department directors, and others responsible for scheduling and organizing meetings within ASUN. The bill aims to improve accessibility, consistency, and transparency in how meetings are conducted, serving as a resource within the Statutes of the Associated Students (SASS) rather than a binding obligation. Moss emphasized that the bill is designed to help ensure meetings are well-structured and inclusive, offering a framework for best practices rather than strict mandates. Following a recent meeting with Director Rodriguez, Moss noted that several key points had been raised that warranted clarification within the bill. Rather than making amendments directly at the table, Moss proposed that the bill be recommitted to the Committee on Government Operations to allow for a more thorough review and refinement of the language. This would ensure that all committee members could weigh in and help shape the necessary amendments.

During the question period, Senator Miceli sought clarification on whether the bill's protocols would apply to informal gatherings of senators. Specifically, he asked if a meeting between himself and two other senators would be considered an "official body" under the bill's definitions. Moss responded that the proposed amendments would clarify that a public governing body is defined as a group of more than three individuals. Therefore, a meeting involving only three senators would not fall under the bill's procedural requirements. After the discussion, Parliamentarian Issa formally motioned to recommit SB93 to the Committee on Government Operations. The motion was seconded by Speaker Pro Tempore Moss and passed by unanimous consent, with no dissent or abstentions. The bill was officially sent back to committee for further revision.

# b. Senator Reports

Senator Barrus- reported on collaborative event planning with Senators Houghtelling and Villa for the upcoming semester. He reached out to Mel Flores regarding public health materials to be distributed at the Health Fit event on August 19th from 5–6 PM. Additionally, he is coordinating with the Department of Nutrition for a September 18th event focused on healthy beverage choices, specifically through the "Rethink Your Drink" initiative. Barras also volunteered with the School of Public Health's heat prevention pilot program, distributing water, fans, and candy to participants. He concluded his report with heat safety tips, advising attendees to reapply sunscreen every two hours, drink water regularly, wear light and loose clothing, and take breaks in shaded or air-conditioned areas.

Senator McAndrews- shared her excitement for the upcoming semester and outlined several legislative initiatives she's been developing over the summer. She is working on a Clubs and Organizations bill, which continues to evolve through ongoing research and discussion. He also introduced a Budget and Finance Data Collection proposal, which has gained traction through collaborative conversations. McAndrews is brainstorming improvements to ASUN's Canvas page with Parliamentarian Issa and Senator Evans. Her focus is on creating sustainable legislation that won't require rewriting each session. She expressed appreciation for ASUN leadership, highlighting productive meetings with Speaker Acklin and President Aglubat, who engaged her on student-impacting legislation.

**Speaker Pro Tempore Moss-** reported on initiatives within the College of Education. He is working with the college's communications director to launch a monthly newsletter aimed at connecting constituents with ASUN updates. Moss also discussed his legislative piece advocating for student-teacher pay, which he hopes to bring to the table early in the fall semester. His goal is to collaborate with the Education Association to push for compensation reform during the current academic year.

Senator Moore- provided a brief report focused on civic engagement initiatives. She is working with Parliamentarian Issa, the Center for Student Engagement, and university libraries to plan a robust Constitution Day event. Evans expressed optimism that this year's celebration will be more impactful than last year's. She also announced that the Student Media Advisory Board successfully appointed a general manager for Wolfpack Radio, completing the leadership roster for student media heading into the semester.
