7. NEW BUSINESS

a. Summer Check-in with Chairs

- Chair Issa: Committee at 100% attendance, engaged in liaison positions, preparing for Constitution Day and events list from CSE. Only issue: difficulty scheduling with Director Taylor (available after Aug. 3). Veterans Luncheon scheduled for Aug. 4.
- Chair Castro: Attendance remains an issue; Atkinson and Miller absent from meetings, leaving liaisons without updates. Considering grant legislation in September.
