6. REPORTS (INFORMATION ONLY)

a. Information on FISH Tour, Alexander Saporito

- Chair Saporito discussed the finalization of the Special Committee's upcoming touring event of the FISH (Friends in Service Helping, Northern Nevada) facilities. Chair Saporito elaborated on transportation, the number of members currently going, and what hour the touring would take place. The event is reported to occur on Friday, September 26th, from 3:00 PM 4:00 PM in Carson City. The Chair emphasized the importance of arriving at the Joe Crowley Student Union by 2:00 PM. Transportation is being coordinated with Senators Villa and Barrus, who have offered to either pick up members or lead a small caravan to the tour site. The group must leave no later than 2:20 PM, with travel expected to take approximately 35 to 40 minutes, allowing for potential traffic.
 - Noted that business casual attire will be appropriate for the tour. The purpose of the
 visit will be to spread organizational presence and open discussion around food
 insecurity on campus. Topics include the removal of SNAP-Ed from UNR an
 the growing need for food storage infrastructure..
- Following the tour, Chair Saporito outlined plans to reach out to a number of state assembly members and senators in support of lobbying efforts tied to security-based student needs. This effort builds on the success from last semester, where UNR's student presence at the Legislature helped influence Assembly Member Erica Roth's approval of A.B. 345. This bill established a committee to gather data on food insecurity from all NSHE institutions.
 - Currently, there is a list of approximately 38 assembly members and 3 state senators being considered for outreach. The relevant committee will review the list during its next meeting to determine priority contacts and any additions.
- Chair Saporito also brought attention to liaison assignments. Members were asked to begin
 contacting their assigned liaisons and to report back on whether the contacts are responsive,
 unresponsive, or redirecting them to someone else.
 - b. Information on upcoming Pack Provisions' "Giving Day" Event, Bridget Tevnan
- Bridget Tevnan announced that her last day in her current role will be Friday. Moving forward, Amy Koeces will be the next point of contact for ongoing collaboration. Additionally, the table was informed about the upcoming event:

"Pack the Pantry" Donation Drive & Tailgate, scheduled for Friday, October 11.

- The event will be held in conjunction with a home football game tailgate, from 5:00 PM to 7:00 PM. Members will be responsible for collecting donations and tabling for Pack Provisions, with a focus on raising awareness about food insecurity and collecting monetary donations.
- A week-long donation drive will take place from Monday, October 6 to Friday, October
 10. Donation bins will be placed outside Legacy Hall to encourage contributions from the inner UNR community.
- Collin Bernard (from Athletics) will assist with publicity efforts, including a press release for the Saturday tailgate event, coverage via the Nevada Sports Network, emails through listservs and social media promotion via the Nevada Athletics and CSE Instagram accounts.
