S.R. 93 -
A RESOLUTION TO REQUEST CLARITY ON
THE ROLLOUT OF PACK AI

IN THE SENATE OF THE ASSOCIATED STUDENTS

AUGUST 20TH, 2025

SUBMITTED TO THE SENATE OF THE ASSOCIATED STUDENTS BY PARLIAMENTARIAN ISSA
CO-SPONSORED BY SENATOR BARRUS & SENATOR MCANDREWS

Whereas, Associated Students of the University of Nevada (ASUN) represents the voice of the undergraduate student body in matters affecting student academic and campus life;

Whereas, the University Administration has announced plans for the implementation of PACK AI across campus platforms;

Whereas, many of these platforms including but not limited to WebCampus are used by nearly all students for coursework and communication;

Whereas, much of the student body has expressed questions and concerns regarding the scope, purpose, and impacts of PACK AI's implementation;

Whereas, it is essential that students are fully informed about changes that directly affect their educational tools, data, and academic experiences;

Whereas, the original resolution, *S.R. 93 - A Resolution to Oppose the Mandatory Integration of PACK AI into Academic Curriculum*, was withdrawn at the August 20th meeting in order to allow the Senate to refine its language and intent for greater clarity;

Whereas, the ASUN Senate is taking measures to ensure all parties are notified and have a united front regarding this issue;

Whereas, this resolution does not take a stance on the use of artificial intelligence or PACK AI itself, but rather emphasizes the importance of transparency and student awareness prior to implementation;

Whereas, the ASUN Senate wishes to be informed on this issue in order to provide full transparency to the student body; and

Whereas, the Associated Students of the University of Nevada continues to foster the relationship with University Administration, in order to best serve the students of the University of Nevada, Reno;

Be it resolved, that the Associated Students of the University of Nevada formally request the University Administration provide a presentation to the ASUN Senate regarding the implementation of PACK AI, including but not limited to its intended functions, impacts on academic platforms, data usage policies, data protection and privacy, student support resources and effects on students fees;

Be it further resolved, that University Administration provide a public announcement to every student addressing impacts on academic platforms, data usage policies, data protection and privacy, student support resources and effects on students fees;

Be it further resolved, that ASUN urges University Administration to make this information available not only to student leadership but also to the broader undergraduate student body, ensuring clarity and transparency in how PACK AI will be integrated into existing academic systems; and that this informed implementation process supports the integrity of ASUN's role in representing students while also reinforcing the leadership of University Administration in carrying out changes that directly affect students;

Be it further resolved, that the ASUN Senate requests that all of the above take place prior to the conclusion of the Fall 2025 semester, to allow adequate time for student input;

Be it further resolved, that ASUN urges University Administration to provide continued updates to student leadership throughout PACK AI's rollout; and

**A Bill
An Act to use Capital Funds for Technology Replacement**

Whereas, an appropriation from the Capital Fund has been requested;

Whereas, the funds are requested to pay for technology replacement in the Frankie Sue Del Papa Conference Room and Pack Place located in the ASUN Center for Student Engagement;

Whereas, ASUN must invest in capital resources to keep its electronic equipment up-to-date;

Whereas, the Frankie Sue Del Papa Conference Room has the ability to host online and hybrid meetings, allowing ASUN to comply with Nevada Open Meeting Law, and the technology to do so was purchased in 2018 and has since been having issues with camera usage, sound, power, and overheating, despite attempts to troubleshoot;

Whereas, Pack Place has two TV's which project images from laptops and AirMedia devices for meetings and activities, of which such devices were purchased in 2015 and have since been unplugged due to security concerns that the exposure of University network information systems could be abused by malicious parties;

Whereas, the request is being made to replace the Frankie Sue Del Papa Conference Room Creston System and TV as well as the two Pack Place Air Media's;

Whereas, the technology replacement will cost \$12,445.11, including a 10% contingency required by the Statutes of the Associated Students for possible price increases from the vendor;

Be it enacted by the Senate of the Associated Students,

- a) The Capital Fund be approved to pay for the \$12,445.11 technology replacement.*

RE: \$12,445.11 Capital Request – Technology Replacement for Conference Room & Pack Place

This request is for new technology in the Frankie Sue Del Papa Presidents Conference Room and Pack Place located in the ASUN Center for Student Engagement. After an assessment of the current technology, it has been determined that an update is needed.

- Frankie Sue Del Papa Presidents Conference Room has the ability to host online and hybrid meetings. This allows ASUN to meet standards for Nevada Open Meeting Law. This system was purchased in 2018. In the last year the technology in the conference has been having issues with camera usage, sound, power issues, TV issues, and recently has been overheating causing it to shut down and not be able to be used. The staff has tried to troubleshoot to fix these problems, and they are no longer working.
- Pack Place has two TV's that project images from laptops from AirMedia devices behind each TV for meetings and activities. These AirMedia devices were purchased in 2015. Two weeks ago, the two AirMedia devices had to be unplugged due to security concerns that the University systems could be abused. The aged devices were exposing the University network to malicious parties.

This request is for new technology for the two areas listed above for a total of \$12,445.11
