Dear Speaker Acklin and Esteemed Members of the Senate,

I am excited to introduce two important pieces of legislation to the Senate:

1. S.R. 93 – A Resolution to Enhance Campus Health Service Awareness via LiberalArtsFIT
2. S.R. 93 – A Resolution to Inform the COLA Student Body on the Services Provided by the Student Health Center via Academic Advising and the COLA Student Hub

I respectfully request that these resolutions be fast-tracked before the end of the semester. Both pieces are mutated versions of my intern project from the 92nd session. Since last October, I have been in close contact with key staff at the Student Health Center, including Malia Sanderson and Cheryl-Hug English, as well as with Brianne Chambers, Director for NevadaFIT, and our Liberal Arts administrative faculty. Over the past year, I have worked closely with these teams to identify ways to better inform students about the resources provided by the Student Health Center.

The Student Health Center offers a wide range of resources that students are already funding, yet many incoming scholars are unaware of them. By improving communication, we can ensure that new students are safer, healthier, and more comfortable on campus.

The first piece I would like to fast-track regards:

S.R. 93 – Enhancing Campus Health Service Awareness via LiberalArtsFIT

This resolution establishes a mandatory and universal method of communication to inform students about the Student Health Center. From my time with NevadaFIT, I observed that many students, including myself, received little to no direct information about the Center. While pamphlets, skill sessions, and parent presentations were available, there was no consistent, universal, or mandatory method to ensure students receive this critical information. Parents may not remember the services offered months later when their child needs them; therefore, creating multiple pathways for students to learn about these resources ensures the University is prioritizing student safety.

The second piece I would like to fast-track regards:

S.R. 93 – Informing the COLA Student Body via Academic Advising and the COLA Student Hub

This resolution further emphasizes student safety by integrating information about the Student Health Center into required academic advising sessions for COLA first-year students. These sessions are designed to support student retention and ensure students stay on track for graduation. During these meetings, students would view a concise and informative video outlining the services available at the Student Health Center. Because these sessions occur during peak illness periods, such as flu season, they provide a timely opportunity to inform students about the Center's resources.

Additionally, this video will be uploaded to the COLA Canvas Student Hub, allowing students to access it at any point during their academic career. After months of collaboration with COLA administrative faculty and Assistant Dean Kristi Van Gorder, all parties are ready to implement this initiative efficiently and effectively.

I am eager for any discussion on these resolutions and am happy to answer any questions. Regardless of the Senate's decision, the outreach and planning over the past year have ensured that these initiatives are fully prepared for implementation. Both COLA administrative faculty and the Student Health Center are committed to producing the necessary materials and hosting LiberalArtsFIT sessions. These resolutions will also encourage other colleges to explore ways to increase Student Health Center representation for their students.

Thank you very much for your time, consideration, and continued support of initiatives that prioritize student health and well-being. I look forward to collaborating with you to bring these initiatives to fruition.

Dear Speaker Acklin and Esteemed Members of the Senate,

Counseling Services has requested that *S.R. 93 - A Resolution to Support Reinstating Men's Group Therapy as a Counseling Service Program* be passed in the Senate. During the few meetings I have had with Counseling Services, they have expressed the need for student support to reinstate the Men's Group Therapy program in a timely manner, saying they think it is just as important as the existing DBT Program.

Additionally, fast-tracking this piece would allow the Senate to express its support for reinstating the program before the end of this semester and the start of Winter Break. This would grant Counseling Services adequate time to prepare for the reinstatement of the program before the start of the Spring 2026 semester, all with the assurance that the Associated Students and the wider student body support the program.

To be clear: the Men's Group Therapy program was removed and replaced with the Dialectical Behavior Therapy, or DBT. Both programs are useful and neither should have to be removed for the other one, that is why I encourage the Senate to fast track this piece so this program can be reinstated and we can help everyone across campus—including men who have not had access to such a valuable resource.

For these reasons, I am requesting that *S.R. 93 – A Resolution in Support of Reinstating Men's Group Therapy as a Counseling Service Program* be fast-tracked for immediate consideration and action.

*Whereas*, providing information through mandatory academic-advising sessions can familiarize students throughout their first year of the campus-services provided at the Student Health Center;

*Whereas*, that the mandatory academic advising sessions will include information about the services provided at the Student Health Center for all COLA first-year students to see;

*Whereas*, that video provided by the SHC will be also documented within the COLA Student-Hub, allowing all students involved within the College of Liberal Arts to access the given information;

*Be it resolved by the Senate of the Associated Students*, that an informational video discussing the services provided by the Student Health Center shall be provided to the College of Liberal Arts and implemented via mandatory academic advising sessions and the COLA Student Hub;

*Be it further resolved by the Senate of the Associated Students*, that the content created shall be managed by the Health Educator found within the Student Health Center or a designated faculty member of the Health Center appointed by the Health Educator;

*Be it further resolved by the Senate of the Associated Students*, that the content provided by the Student Health Center shall be transcribed onto Canvas by the Coordinator of Academic Advising within the College of Liberal Arts;

*Be it further resolved by the Senate of the Associated Students*, that the Health Educator/Designated Appointee has the final say on the content provided and transcribed within the COLA Student Health Center informational video;

*Be it further resolved by the Senate of the Associated Students*, that the video provided shall be incredibly informational while also being short, landing under three minutes;

---

*Whereas*, the Associated Students of the University of Nevada (ASUN) serves as the representative body for over 18,000 undergraduate students, and its programs, services, and funding exist for the collective benefit of students rather than for the personal recognition of individual officers; and

*Whereas*, the Association's programs carry a long institutional lifespan, often extending well beyond the terms of the elected officials who create them, and should therefore uphold principles of neutrality, professionalism, and continuity; and

*Whereas*, naming programs after sitting ASUN officers risks conveying a perception of self-promotion, self-aggrandizement, or legacy-building, which undermines the Association's credibility, introduces subjective political considerations, and shifts attention away from the students and communities these programs are intended to serve; and

*Whereas*, the practice of naming ASUN programs after officers may inadvertently pressure future administrations to continue this precedent or feel compelled to create similarly named initiatives to maintain political relevance, contrary to the broader mission of serving students and advancing institutional equity; and

*Whereas*, two current examples include the "Guerra-Alquiza Passion Fund," named after former ASUN President Boris Carpio Guerra and former ASUN Vice President Hannah Alquiza, and the "Deal-Kemmelmeier ASUN Pack Grad School Fund," named after former ASUN President Dawson Deal and former ASUN Vice President Liesel Kemmelmeier; and

*Whereas*, it is in the long-term interest of the Association to establish expectations that guide future conduct without creating division, eroding trust, or retroactively altering the historical record of ASUN;

*Whereas*, ASUN has numerous opportunities to recognize and honor outstanding student leadership through awards, certificates, or historical documentation, which do not compromise program objectivity or the professional neutrality expected of a governing body; and

*Whereas*, it is in the long-term interest of the Association to ensure programs are known for their purpose and impact rather than for their association with individual officeholders;

***THE STUDENTS OF THE UNIVERSITY OF NEVADA REPRESENTED IN THE

# Addendum A

## INTRODUCTION

### CHAPTER 002: CODE OF CONDUCT

#### SECTION 05: SELF-PROMOTIONAL CONDUCT

- a) No officer of the Associated Students shall engage in self-promotional conduct that uses the authority or resources of their office for personal visibility, prestige, or legacy-building.
- b) No officer shall name, or cause to be named, any program, fund, service, initiative, award, or similar institutional resource after themselves or any other current officer of the Association, except as expressly permitted by law under extraordinary circumstances approved by a two-thirds vote of the Senate.
- c) Officers shall not solicit, request, or encourage the naming of any ASUN resource in their honor, nor shall they encourage others to do so on their behalf.
- d) Officers shall ensure that institutional programs and services remain student-centered and mission-driven, and shall not engage in conduct that associates such resources with their individual identity beyond the factual historical record.

#### SECTION 06: OFFICER BEHAVIOR

- a) Officers of the Associated Students shall behave in such a way as to uphold and advance the integrity of the Association's reputation while acting in an official capacity.
- b) ASUN officers shall hold their position in the highest regard.
- c) The reputation of the Associated Students is dependent on the trust and confidence the officers earn from the students at the University of Nevada. Officers gain credibility by adhering to their commitments, displaying honesty and integrity, and reaching Association and department goals solely through honorable conduct.
- d) Violations of these may result in judicial action.

#### SECTION 07: ENFORCEMENT

The Director of Ethics and Compliance of the Association shall be responsible for enforcing the provisions of this chapter. This may be done through advisory opinions or judicial charges.



# Addendum B

## CODE OF ETHICS

### SECTION 9: SELF-PROMOTION

Officers shall:

- a) Ensure that programs, funds, services, and initiatives of the Associated Students remain institutionally neutral and free from personalization that implies individual ownership, authorship, or branding.
- b) Refrain from affixing their names or likenesses to any ASUN program, service, or initiative in a manner that suggests personal credit, legacy-building, or self-identification with institutional resources.
- c) Avoid conduct that creates the impression that ASUN programs or initiatives are tied to the identity or tenure of any individual officeholder rather than to the mission and continuity of the Association.
- d) Rely exclusively on established forms of recognition (e.g., awards, certificates, and official documentation) when acknowledging contributions, and shall not seek permanent or semi-permanent institutional naming in their honor.
- e) Preserve the distinction between personal achievement and institutional function by ensuring that no action taken in office results in a program or initiative being publicly associated with their name beyond the historical record.

*Whereas*, Men’s Group Therapy is a previous existing resource provided by Counseling Services; and

*Whereas*, Men’s Group Therapy got removed and replaced with Dialectical Behavior Therapy (DBT), provided by Counseling Services; and

*Whereas*, Counseling Services has expressed strong interest in bringing back the Men’s Group Therapy program; and

*Whereas*, Men’s Group Therapy has several benefits, including making sure men across campus feel as if they have a safe place to express their feelings and ensuring that men have a place where they don’t feel isolated<sup>1</sup>; and

*Whereas*, 38% of men ages 18-34 have avoided talking to others about their feelings to avoid appearing “unmanly”; and

*Whereas*, 53% of men ages 18-34 say they feel pressure to be “manly”<sup>2</sup>; and

*Whereas*, this stigma has created an unhealthy mindset and environment for men around campus; and

*Whereas*, 39% of men say they at times change their behavior to appear more masculine, with 10% saying they do it “frequently”; and

*Whereas*, more than a quarter of men (29%) say they’ve purposefully not shown emotion or held back from crying in front of others in order to preserve their masculinity; and

*Whereas*, 22% say they’re “unlikely” to talk to someone even if they’re dealing with a problem they’re having trouble coping with; and

*Whereas*, the current procedure to discharge legislation from consideration in committees is unclear; and

*Whereas*, this lack of clarity creates unnecessary confusion and inconsistent application of Senate rules; and

*Whereas*, procedural ambiguity has the effect of delaying the approval or failure of legislation; and

*Whereas*, such delays may impede the Senate's ability to respond promptly to time-sensitive student needs and institutional matters; and

*Whereas*, unclear discharge procedures may discourage Senators from exercising their right to advance stalled legislation through appropriate parliamentary means; and

*Whereas*, clearly defined discharge procedures promote fairness, transparency, and accountability in the legislative process; and

*Whereas*, institutional trust in the Senate's governance depends on predictable and uniformly applied rules; and

*Whereas*, a revised discharge procedure will allow Senators to more easily and consistently move legislation from committee to the Senate table when necessary; and

*Whereas*, the revised procedure maintains the same general structure as the previous rule while clarifying its application; and

*Whereas*, the process for submitting a motion to discharge will remain unchanged to preserve continuity of practice; and

*Whereas*, the order of consideration for discharged legislation will remain unchanged to preserve Senate precedent; and

*Whereas*, the timeline by which legislation may be discharged will be clearly defined; and



*Whereas*, the voting threshold required to approve a motion to discharge will be clearly established; and

*Whereas*, the manner in which the Senate considers discharge motions and the affected legislation will be standardized; and

*Whereas*, these revisions are necessary to ensure that the Senate's committee procedures function efficiently, equitably, and in accordance with principles of good and effective governance;

# Addendum A

## Rule XII: COMMITTEE PROCEDURE

### c) DISCHARGE FROM CONSIDERATION

- 1) A senator may present to the Speaker of the Senate a motion in writing to discharge a committee from consideration of legislation that has been referred to it for 14 days, with the first day being the day of referral of that legislation to the committee. Only one motion may be presented for a single piece of legislation.
- 2) The Speaker shall cause the motion to be placed on the agenda at the next scheduled Senate meeting. The affected legislation shall be placed preliminarily under the same agenda item as all other legislation being considered at the Senate table.
- 3) When a motion to discharge is on the agenda, the Senate shall proceed to its consideration under this paragraph without intervening motion except one motion to adjourn. Motions to discharge shall have precedence in the order of submission to the Speaker.
- 4) When a motion to discharge is considered, the legislation to which it relates shall be read by title only. The motion is debatable for 20 minutes, one-half in favor of the motion and one-half in opposition thereto.
- 5) If a motion prevails to discharge a committee from consideration of legislation, the Senate shall immediately consider the legislation under the general rules of the Senate. A motion to discharge requires a majority of the membership to adopt.
- 6) When a motion to discharge originated under this clause has once been acted on by the Senate, it shall not be in order to entertain during the same session of the Senate a motion to discharge a committee from consideration of that legislation or of any other legislation that, by relating in substance to or dealing with the same subject matter, is substantially the same.
- 7) A motion to discharge on the agenda that is rendered out of order under paragraph (6) shall be stricken.

**An Act to**

1       *Whereas* SAS 101.13.a states, “On the first day of December, or within one week thereafter,  
2 of the Seventy-Ninth session of the Senate and of each Senate thereafter, the President shall  
3 transmit to the Senate a statement showing the whole number of persons in each college and  
4 school, and the number of Representatives to which each college and school would be entitled  
5 under an apportionment of the then existing number of Senators. The apportionment method used  
6 shall be the Huntington-Hill Method of Equal Proportions, whereby each seat is designated in  
7 sequence to the college with the highest priority value in descending order.”;

8       *Whereas*, the Office of the President has completed the duties outlined in SAS 101.13.a;

9       *Whereas*, SAS 101.13.b states, “It shall be the duty of the Secretary of the Senate, within  
 10 fifteen calendar days after the receipt of such statement, to send to the Commission on  
 11 Association Elections a certificate of the number of Senators to which such college or school is  
 12 entitled under this section. In case of a vacancy in the office of Secretary, or his or her absence or  
 13 inability to discharge this duty, then such duty shall devolve on the Legislative Clerk.”

14       *Whereas*, the Secretary of the Senate has sent the required certification of the number of  
 15 Senators to which each college or school is entitled to the Elections Commission;

16       *Whereas*, SAS 101.13.c states, “The basis of apportionment figures shall be the enrollment  
 17 headcount of undergraduate students in each college and school that is not an administrative unit  
 18 of another college or school as of the University census date for the fall semester next preceding  
 19 reapportionment. The headcount shall accurately reflect actual membership in the Association, in  
 20 accordance with the Constitution”;

21       *Whereas*, the Office of the President has been provided the census for Fall 2025 registration  
 22 of students at the University of Nevada by Colleges and Schools. The whole number of persons in  
 23 each college and school are as follows:

- 24           1. College of Agriculture, Biotechnology, and Natural Resources: **1,048**
- 25           2. College of Business: **3,079**
- 26           3. College of Education: **821**
- 27           4. College of Engineering: **2,536**
- 28           5. Honors College: **1,250**

*Whereas*, Senate Rule II.f.5.x. states: “Failure of the Chairperson of a committee, including the Committee on Oversight, to hold a meeting within the required two-week period shall be the equivalent of two points”; and
