  - Chair Saporito reported on initiatives to support students in need and expand food access; Amy Koeckes is working with Pack Provisions, FBNN, and Safeway to distribute grocery cards, with details on amounts pending. FBNN will provide 12 truckloads of food, and additional donations will come from DFI. The Dining Hall swipe drive (11/18–12/9) will allow students to donate up to 10 swipes per week, with a new donation bank system helping eligible students automatically receive extra swipes. Volunteers are needed for FBNN and Pack Provisions throughout December. The Food & Coat Drive runs Nov 10–Dec 10, with Pack Rides vans collecting donations on campus and at local event sites. In partnership with Programming, Sustainability, and SCFI, the farmers market initiative will expand to monthly dispersed markets next semester.
