AN ACT TO USE CAPITAL FUNDS TO REPLACE ASUN TV MONITORS

IN THE SENATE OF THE ASSOCIATED STUDENTS

SUBMITTED TO THE SENATE OF THE ASSOCIATED STUDENTS BY PRESIDENT AGLUBAT, SPONSORED BY
CHAIR OF BUDGET AND FINANCE MOSS

Whereas, an appropriation from the Capital Fund has been requested;

Whereas, the request is to replace ASUN TV monitors throughout campus.

Whereas, these are the current locations of the ASUN TV monitors owned and operated by ASUN. Each location has a computer that runs AxixTV software:

1. The Joe Second Floor & Third Floor
2. The Joe First Floor
3. Lombardi Recreation

4. Church Fine of Arts (CFA)
5. Scrugham Engineering (SEM)
6. Davidson Math & Science Center (DMS) – 2 on the first floor
7. William Raggio Building (WRB)
8. Frandsen Humanities

Whereas, these TV monitors are used to assist with marketing of events, programs, and announcements;

Whereas, These TV monitors run from a software called AxixTV which allows centralized ads to be placed, calendar feature to remove old ads and is hooked up the alert system that UNRPD has access to in case of an emergency

Whereas, recently, Microsoft announced that they would stop supporting Windows 10 in October 2025. The current computers that are running the AxisTV program are Windows 10 and will not be able to move to Windows 11 as required by the University for security.

Whereas, new TV monitors are required to keep up with the evolving technology to continue its high quality and effective advertising;

Whereas, replacing the ASUN TV monitors will cost \$7,080.00;

Be it enacted, by the Senate of the Associated Students, that the Capital Fund be approved to spend \$7,080.00 to purchase new TV monitors.

Be it further enacted, that, if by necessity, an additional 10% contingency fund shall be appropriated for the purposes of this bill.

AN ACT TO USE CAPITAL FUNDS TO PARTIALLY FUND THE PURCHASE OF A NEW ADA ACCESSIBLE VEHICLE

IN THE SENATE OF THE ASSOCIATED STUDENTS

DECEMBER 2025

SUBMITTED TO THE SENATE OF THE ASSOCIATED STUDENTS BY PRESIDENT AGLUBAT, SPONSORED BY
CHAIR OF BUDGET AND FINANCE MOSS

Whereas, an appropriation from the Capital Fund has been requested;

Whereas, the request is to purchase a new vehicle that will provide ADA transportation
for our student body through Pack Rides;

Whereas, the necessity of a new ADA vehicle has been stated by the Pack Rides
program;

Whereas, the program currently operates one ADA vehicle that provides rides for

students, which was purchased in 2017 and currently has over 60,000 miles. They have an additional ADA vehicle that was purchased in 2008, but it is no longer in working condition and does not have a motorized ADA lift for passengers.

Whereas, an additional vehicle will provide more rides and allow ASUN Pack Rides to continue offering ADA rides even when one of the ADA vehicles requires maintenance or repairs.

Whereas, the Association is presented a unique opportunity to have the vehicle partially funded through donations, although the window of opportunity is limited.

The Department of Advancement at the University has informed ASUN Pack Rides that there has been a donation of \$20,583.15 towards an ADA vehicle. This donation must be used within the next six months; otherwise, the donation will be returned;

Whereas, the cost breakdown of the vehicle is outlined below:

- Total needed for new ADA vehicle: \$92,662.58
 - Donation Amount: \$20,583.15
 - ASUN Capital Request: \$72,079.43

Be it enacted, by the Senate of the Associated Students, that the Capital Fund be approved to spend \$72,079.43 to purchase a new ADA accessible vehicle.

Be it further enacted, that, if by necessity, an additional 10% contingency fund shall be appropriated for the purposes of this bill.

**A BILL TO CLARIFY THE APPOINTMENT
PROCESS OF THE SPEAKER'S
REPLACEMENT**

IN THE SENATE OF THE ASSOCIATED STUDENTS

JULY 5TH, 2025

SUBMITTED TO THE SENATE OF THE ASSOCIATED STUDENTS BY PARLIAMENTARIAN ISSA
ORIGINALLY AUTHORED BY SENATOR TERRY

Whereas, after the election of Speaker Acklin in the 93rd session, the leadership of the Senate found confusion in the process of appointing a replacement; and

Whereas, the current language of the SAS currently states “the first runner-up from the college or school of which the newly elected Speaker were elected...”¹; and

Whereas, the leadership of the Association at this time deemed it right to exhaust all runners-up in order of most to least votes as a replacement for the Speaker before moving on to appointment processes determined elsewhere; and

Whereas, clarifying this process will allow for smooth transitions of sessions in the future by removing any delay in appointing the replacement of the Speaker; and

Whereas, the current statutory language does not explicitly define whether runner-up candidates must be considered in strict descending vote-count order, resulting in differing interpretations among Senate leadership teams; and

Whereas, this ambiguity created practical uncertainty for both elected officials and administrative staff during the transition into the 93rd Session, demonstrating the need for greater clarity; and

Whereas, establishing a clear, uniform appointment procedure supports smooth transitions and avoids procedural disputes at the start of future sessions; and

Whereas, clarifying the sequence in which runner-ups must be considered ensures that future appointments are based on transparent, objective criteria rather than subjective or arbitrary decision-making; and

Whereas, prioritizing candidates based on the number of votes they received preserves the democratic legitimacy of the Senate by giving preference to individuals who earned the greatest support from their constituents; and

Whereas, such clarity strengthens continuity of representation for the students within the Speaker's college, who may otherwise face prolonged vacancies or inconsistent representation; and

Whereas, maintaining well-articulated statutes fulfills the Senate's obligation to uphold good governance, transparency, and consistent application of its internal rules; and

Whereas, updating the SAS to resolve this ambiguity will allow the Senate to function more efficiently and more effectively serve the students of the University of Nevada, Reno;

***THE STUDENTS OF THE UNIVERSITY OF NEVADA REPRESENTED IN THE
SENATE, Do ENACT AS FOLLOWS:***

Addendum A

TITLE I: THE LEGISLATIVE BRANCH

CHAPTER 102: TRANSITION OF SESSIONS

SECTION 05: ELECTION OF SPEAKER

- a) Immediately following the ascertainment of a quorum, the Senate shall proceed to the election of the Speaker. Only newly elected Senators are eligible to be nominated and elected to the position of Speaker of the Senate. No other business shall be in order except to recess or adjourn until a Speaker, or a Speaker Pro-Tempore, has been selected.
- b) When no further nominations have been received, the Secretary shall recognize each nominee to deliver a 10-minute presentation to the Senate.
- c) The Senate shall be able to question and debate the nominees. At no time during the election of the Speaker shall the Secretary recognize any person not entitled to the floor of the Senate unless the Senate orders otherwise.
- d) At the conclusion of debate, the Secretary shall put the question of the election of the Speaker by roll call vote. The Secretary shall call the roll and each Senator shall indicate by surname the nominee of the individual Senators choice. A majority is required for the election of the Speaker.
- e) In the event that a single candidate does not receive a majority of votes, the Secretary of the Senate shall call for rounds of voting, eliminating the candidate with the fewest votes, each round until a single candidate receives a majority of the votes. In the event two or more candidates are tied with the least amount of votes, a runoff vote will occur between those candidates to identify which candidate to remove from voting.
- f) After the election of the Speaker, the first runner-up from the college or school of which the newly elected Speaker were elected shall be appointed to the Senate at the meeting following the election of the Speaker. Should the first runner-up be unwilling or unable to take this appointment for any reason, the next runner-up shall be appointed. This process shall continue until either a runner-up has accepted the appointment or all runners-up have denied the appointment.
 - 1) Such appointments do not need approval from the Senate.
 - 2) If there was no runner-up from the college of which the Speaker was elected, the Senate shall fill the vacancy as the Senate by law provides to fill any other vacancy of the Senate.

Whereas, this piece accompanies the binding resolution of the same name; and *Whereas*, the Associated Students of the University of Nevada strives to promote and maintain transparency and accountability with the student body; and

Whereas, documentation of Senate Outreach provides valuable insight on the actions of Senators throughout their session; and

Whereas, documentation of Senate Outreach is used within the Senate to determine if Senators are adhering to their duties to the best of their ability; and

Whereas, the Senate Outreach Form is currently used internally for evaluation but is not publicly accessible to the student body, limiting the ability of students to understand the work their elected representatives perform outside Senate chambers; and

Whereas, other documentation in the Association, such as the sessional Legislation Tracker, SAS, and Rules of the Senate are publicized on the ASUN website¹ to maintain transparency for the student body; and

Whereas, previous Senator and current President Carmina Aglubat had passed *S.B. 91 - An Act to Publicize the Senate Legislation Tracker* at the April 3rd, 2024 meeting of the Senate², to continue the promotion of transparency of the Senate of the Associated Student's legislative affairs to the student body; and

Whereas, publicization of the Senate Outreach Form would allow student media, such as the Nevada Sagebrush, to have better access to what individual Senators have been involved in outside of Senate meetings and legislative affairs; and

TITLE I: THE LEGISLATIVE BRANCH

CHAPTER 101: COMPOSITION

SECTION 08: PARLIAMENTARIAN

The Speaker shall appoint from the membership of the Senate a Parliamentarian, subject to the majority approval of the Senate, who shall advise the Speaker and individual Senators on matters of Senate procedure, the law, and the Constitution of the Associated Students. The Parliamentarian shall be informally trained along with or by the Director of Ethics and Compliance of the Association within 14 days of assuming office and shall informally train officers and department directors on parliamentarian procedures. The Parliamentarian shall correspond with the Center for Student Engagement's IT Technician to publish and maintain public accessibility of the Senate Outreach Form on the ASUN website, and such correspondence shall occur no later than one week following the conclusion of the previous outreach period. The Parliamentarian shall assume a voting position within the Committee of Oversight and the Committee on Government Operations.

Whereas, documentation of Senate Outreach is used within the Senate to determine if Senators are adhering to their duties to the best of their ability; and

**AN ACT TO PROHIBIT SELF-PROMOTIONAL
NAMING PRACTICES**

IN THE SENATE OF THE ASSOCIATED STUDENTS

SUBMITTED TO THE SENATE OF THE ASSOCIATED STUDENTS BY PARLIAMENTARIAN ISSA

Whereas, the Associated Students of the University of Nevada (ASUN) serves as the representative body for over 18,000 undergraduate students, and its programs, services, and funding exist for the collective benefit of students rather than for the personal recognition of individual officers; and

Whereas, the Association's programs carry a long institutional lifespan, often extending well beyond the terms of the elected officials who create them, and should therefore uphold principles of neutrality, professionalism, and continuity; and

Whereas, naming programs after sitting ASUN officers risks conveying a perception of self-promotion, self-aggrandizement, or legacy-building, which undermines the Association's credibility, introduces subjective political considerations, and shifts attention away from the students and communities these programs are intended to serve; and

Whereas, the practice of naming ASUN programs after officers may inadvertently pressure future administrations to continue this precedent or feel compelled to create similarly named initiatives to maintain political relevance, contrary to the broader mission of serving students and advancing institutional equity; and

Whereas, two current examples include the "Guerra-Alquiza Passion Fund," named after former ASUN President Boris Carpio Guerra and former ASUN Vice President Hannah Alquiza, and the "Deal-Kemmelmeier ASUN Pack Grad School Fund," named after former ASUN President Dawson Deal and former ASUN Vice President Liesel Kemmelmeier; and

Whereas, it is in the long-term interest of the Association to establish expectations that guide future conduct without creating division, eroding trust, or retroactively altering the historical record of ASUN;

Whereas, ASUN has numerous opportunities to recognize and honor outstanding student leadership through awards, certificates, or historical documentation, which do not compromise program objectivity or the professional neutrality expected of a governing body; and

Whereas, it is in the long-term interest of the Association to ensure programs are known for their purpose and impact rather than for their association with individual officeholders;

Addendum A

INTRODUCTION

CHAPTER 002: CODE OF CONDUCT

SECTION 05: SELF-PROMOTIONAL CONDUCT

- a) No officer of the Associated Students shall engage in self-promotional conduct that uses the authority or resources of their office for personal visibility, prestige, or legacy-building.
- b) No officer shall name, or cause to be named, any program, fund, service, initiative, award, or similar institutional resource after themselves or any other current officer of the Association, except as expressly permitted by law under extraordinary circumstances approved by a two-thirds vote of the Senate.
- c) Officers shall not solicit, request, or encourage the naming of any ASUN resource in their honor, nor shall they encourage others to do so on their behalf.
- d) Officers shall ensure that institutional programs and services remain student-centered and mission-driven, and shall not engage in conduct that associates such resources with their individual identity beyond the factual historical record.

SECTION 06: OFFICER BEHAVIOR

- a) Officers of the Associated Students shall behave in such a way as to uphold and advance the integrity of the Association's reputation while acting in an official capacity.
- b) ASUN officers shall hold their position in the highest regard.
- c) The reputation of the Associated Students is dependent on the trust and confidence the officers earn from the students at the University of Nevada. Officers gain credibility by adhering to their commitments, displaying honesty and integrity, and reaching Association and department goals solely through honorable conduct.
- d) Violations of these may result in judicial action.

SECTION 07: ENFORCEMENT

The Director of Ethics and Compliance of the Association shall be responsible for enforcing the provisions of this chapter. This may be done through advisory opinions or judicial charges.

Addendum B

CODE OF ETHICS

SECTION 9: SELF-PROMOTION

Officers shall:

- a) Ensure that programs, funds, services, and initiatives of the Associated Students remain institutionally neutral and free from personalization that implies individual ownership, authorship, or branding.
- b) Refrain from affixing their names or likenesses to any ASUN program, service, or initiative in a manner that suggests personal credit, legacy-building, or self-identification with institutional resources.
- c) Avoid conduct that creates the impression that ASUN programs or initiatives are tied to the identity or tenure of any individual officeholder rather than to the mission and continuity of the Association.
- d) Rely exclusively on established forms of recognition (e.g., awards, certificates, and official documentation) when acknowledging contributions, and shall not seek permanent or semi-permanent institutional naming in their honor.
- e) Preserve the distinction between personal achievement and institutional function by ensuring that no action taken in office results in a program or initiative being publicly associated with their name beyond the historical record.

Whereas, the current procedure to discharge legislation from consideration in committees is unclear; and

Whereas, this lack of clarity creates unnecessary confusion and inconsistent application of Senate rules; and

Whereas, procedural ambiguity has the effect of delaying the approval or failure of legislation; and

Whereas, such delays may impede the Senate's ability to respond promptly to time-sensitive student needs and institutional matters; and

Whereas, unclear discharge procedures may discourage Senators from exercising their right to advance stalled legislation through appropriate parliamentary means; and

Whereas, clearly defined discharge procedures promote fairness, transparency, and accountability in the legislative process; and

Whereas, institutional trust in the Senate's governance depends on predictable and uniformly applied rules; and

Whereas, a revised discharge procedure will allow Senators to more easily and consistently move legislation from committee to the Senate table when necessary; and

Whereas, the revised procedure maintains the same general structure as the previous rule while clarifying its application; and

Whereas, the process for submitting a motion to discharge will remain unchanged to preserve continuity of practice; and

Whereas, the order of consideration for discharged legislation will remain unchanged to preserve Senate precedent; and

Whereas, the timeline by which legislation may be discharged will be clearly defined; and

Whereas, the voting threshold required to approve a motion to discharge will be clearly established; and

Whereas, the manner in which the Senate considers discharge motions and the affected legislation will be standardized; and

Whereas, these revisions are necessary to ensure that the Senate's committee procedures function efficiently, equitably, and in accordance with principles of good and effective governance;

Rule XII: COMMITTEE PROCEDURE

c) DISCHARGE FROM CONSIDERATION

- 1) A senator may present to the Speaker of the Senate a motion in writing to discharge a committee from consideration of legislation that has been referred to it for 14 days, with the first day being the day of referral of that legislation to the committee. Only one motion may be presented for a single piece of legislation.
- 2) The Speaker shall cause the motion to be placed on the agenda at the next scheduled Senate meeting. The affected legislation shall be placed preliminarily under the same agenda item as all other legislation being considered at the Senate table.
- 3) When a motion to discharge is on the agenda, the Senate shall proceed to its consideration under this paragraph without intervening motion except one motion to adjourn. Motions to discharge shall have precedence in the order of submission to the Speaker.
- 4) When a motion to discharge is considered, the legislation to which it relates shall be read by title only. The motion is debatable for 20 minutes, one-half in favor of the motion and one-half in opposition thereto.
- 5) If a motion prevails to discharge a committee from consideration of legislation, the Senate shall immediately consider the legislation under the general rules of the Senate. A motion to discharge requires a majority of the membership to adopt.
- 6) When a motion to discharge originated under this clause has once been acted on by the Senate, it shall not be in order to entertain during the same session of the Senate a motion to discharge a committee from consideration of that legislation or of any other legislation that, by relating in substance to or dealing with the same subject matter, is substantially the same.
- 7) A motion to discharge on the agenda that is rendered out of order under paragraph (6) shall be stricken.

1 *Whereas*, the ASUN Senate conducts legislative debate under the Senate Rules of the 93rd
2 Session;

3 *Whereas*, Rule XXIII(b) states that all matters not expressly covered by the Senate Rules are
4 governed by Robert's Rules of Order;

5 *Whereas*, under Robert's Rules, a motion for the previous question (to close debate) may be
6 moved at any time, even if no speaker in opposition has been recognized;

7 *Whereas*, neither the Senate Rules nor the Statutes of the Associated Students provide any
8 guarantee that at least one Senator opposing a measure may speak before debate is prematurely
9 ended;

10 *Whereas*, the absence of such protection enables the majority to silence minority viewpoints
11 by calling the previous question before all perspectives are heard;

12 *Whereas*, a minority, for the purposes of debate, consists of Senators opposing the pending
13 motion who have not yet been afforded the opportunity to claim the floor prior to a vote on the
14 previous question;

15 *Whereas*, procedural fairness and democratic deliberation require that debate not be closed
16 before at least one Senator seeking to speak in opposition has had the opportunity to do so;

17 *Whereas*, the Senate has a responsibility to maintain equitable participation within debate,
18 especially for Senators representing underrepresented viewpoints or constituencies; and

19 *Whereas*, creating a clear rule ensuring that a Senator who has not yet spoken may claim the
20 floor before the Senate votes on a motion to close debate promotes transparency, fairness, and the
21 integrity of the legislative process; therefore,

22 *Be it resolved*, that the 93rd Session of the Senate of the Associated Students hereby adopts
23 the changes set forth in Addendum A into the Rules of the Senate;

24 *Be it further resolved*, that a copy of this resolution be sent to the following:

25 • Parliamentarian of the 93rd Senate of the Associated Students, Jason Issa;

26 • President of the Associated Students, Carmina Aglubat;

27 • Speaker of the 93rd Senate of the Associated Students, Leaf Acklin.

ADDENDUM A

RULE VI: CONDUCT OF DEBATE

a) QUESTIONS IN DEBATE

Once debate has begun, a Senator speaking in debate shall be entitled to yield the floor to other Senators for questions. A Senator desiring to ask a question of the speaking Senator may interrupt him, her, or them to request that the speaking Senator yield. The speaking Senator's response to such questions shall be counted against his, her, their debate time.

b) PROTECTION OF DEBATE RIGHTS

- 1) Before a vote may be taken on any motion to move the previous question (to close debate), any Senator who has not yet spoken on the question before the body shall have the right to claim the floor.
- 2) Upon a Senator rising and stating, "I claim the floor as a Senator who has not yet spoken," the Speaker shall recognize the Senator prior to proceeding to a vote on the motion for the previous question.
- 3) This right may only be exercised once per Senator per item of legislation during its second reading.
- 4) This rule shall not apply if:
 - i. The Senator has already spoken on the legislation during second reading;
 - ii. The Senator was recognized but yielded the floor without speaking; or
 - iii. The Senator is not seeking the floor at the time the motion is made.
- 5) After the Senator has spoken or declines to utilize the opportunity, the Senate may immediately proceed to vote on the motion to move the previous question, subject to the required two-thirds threshold under Robert's Rules of Order.
- 6) The protected speech granted under this section shall be limited to a maximum of one (1) minute unless extended by majority consent of the body.
- 7) This protection may not be used for the purpose of delaying proceedings of the body, and may be ruled dilatory by the Chair, subject to appeal of the body.
