  - The report from Director Hatch was skipped due to her attendance at the NSHE Board of Regents meeting.
- b. Committee member reports

    - The Chair reported ongoing DCE liaison check-ins, including meetings with Senators Behrs and Dayton, and noted the need to reschedule a meeting with Senator Atkinson and to schedule a meeting with Senator Burroughs. The Chair announced the initiation of drafting a binding resolution to reform and clarify committee liaison duties, including the potential creation of two additional liaison positions.   - ii. Vice Chair Radtke — Department of Government Affairs
    - Vice Chair Radtke reported meeting with Director Hatch to discuss collaboration between Democratic Civic Engagement and Government Affairs, building upon ideas proposed by former Director Taylor. Discussion included increased coordination, involvement in Department Event Week in late January, and participation in voter engagement and get-out-the-vote efforts.
  - iii. Senator Atkinson — Office of Service Learning and Civic Engagement
    - Absent from the meeting.
  - iv. Senator Barrus — Coordinator of Student Engagement Outreach
    - Senator Barrus reported efforts to connect with liaison Kathy Castro and expressed intent to follow up.
  - v. Senator Burrows
    - Absent from the meeting.
  - vi. Senator Castro — President's Office of Government Relations and Community Engagement
    - Senator Castro reported meeting with Austin Daly to discuss a proposed quarterly event series focused on local government engagement, connecting students with local governing bodies. She also discussed preliminary planning for a veterans-related event and was advised to coordinate with John Pratt from Veterans Services.
  - vii. Senator Dayton — Associate Director of Student Engagement

- Senator Dayton reported ongoing coordination with Justin Berger regarding shuttle logistics for volunteer-related transportation and indicated an update would be provided at the next meeting.

- Senator Evans reported progress on the lab coat donation initiative in coordination with Director Mendoza. Collection bins were expected to arrive imminently, with distribution planned for the following week. - a. S.R. 93 - A Resolution to Condemn the Elimination of Telephonic Public Testimony in the Nevada State Assembly During the 36<sup>th</sup> Special Session

Chair Issa presented S.R. 93, outlining concerns regarding the Assembly's decision to eliminate telephonic public testimony during the 36th Special Session. The Chair emphasized the disproportionate impact on students and others unable to travel to Carson City due to financial, transportation, or scheduling constraints. The Chair noted that both President Aglubat and Director Hatch supported the resolution's current wording.

**Discussion:**

Senator Evans, a co-sponsor, spoke in strong support of the resolution, highlighting the accessibility barriers posed by the elimination of telephonic testimony and sharing personal concerns regarding transportation limitations. No further discussion occurred.

Chair Issa sought unanimous consent to favorably recommend S.R. 93 to the Senate.
