Motion to recess for 2 minutes at 4:23PM, meeting called to order at 4:25 pm.

- The "donation center" was designed for students to donate and take meal swipes, this would act as another thing to help students but not designed to solve food insecurity in the dining halls and created for Pack Place only. Price met with Chair Saporito and director of Pack Provisions to discuss adding this into the dining hall, needed to change the layout due to concerns with adding more work onto the dining hall. The donation center would be one kiosk that students could use if they needed extra swipes. Could use ASUN budget to ensure that there would be a minimum of swipes available. Planning on using excel sheet that would be coded to check the balance, and have someone already working at the register of Pack Place to track the excel spread sheet. Price has done outreach through asking those around him if they thought this would benefit students. Managing who can and cannot take, decided that anyone with zero swipes could take swipes. Silver plan would not fall under the zero swipes since they get 50 meal swipes/week, but all meal plans could donate. This would be separate from the semester drives that Pack Place holds every semester. Price would like more input on this idea, what would make this more efficient and effective for students and Pack Place.
