Re: Dismissal of Impeachment Inquiry – Rock v. Navarte II

The Judicial Council has received a written petition from Kaitlyn Rock requesting dismissal of the charges filed on January 22, 2026. The charges alleged violations of Article III, Section 4 of the ASUN Constitution by Director of IDEA Zyna Navarte. After review of the petition, the Judicial Council unanimously orders that the charges be dismissed.

Factual Background:

On January 22, 2026, the Judicial Council received a charge sheet submitted by Kaitlyn Rock. The charge alleged that Director Navarte violated Article III, Section 4 of the ASUN Constitution. The matter was accepted and disclosed in accordance with the Judicial Rules of Procedure.

Subsequently, the Council received a written petition from Ms. Rock on February 10, 2026, requesting dismissal of the charges. The petition states that the request was made voluntarily following personal deliberation and reflection. The request was unconditional.

Analysis of the Judicial Council:

The Judicial Council possesses authority to adjudicate matters properly brought before it. This authority includes discretion to dismiss a charge upon the petitioner's request prior to final adjudication. The petitioner has formally requested dismissal. No final ruling has been issued in this case. Under these circumstances, dismissal is appropriate.

This dismissal is procedural in nature. It is based solely on the petitioner's withdrawal of the charge. It is not an official decision regarding the culpability, responsibility, or conduct of Director Navarte. The Council makes no findings of fact. The Council does not determine whether the alleged conduct occurred. The substantive merits of the allegations remain unaddressed.

The Judicial Council will take no further action in this matter. The case is closed and will no longer be reviewed by this body.

Directive to the Committee on Oversight:

As a result of this dismissal, there is no pending judicial matter arising from the January 22, 2026 charge. The Judicial Council therefore directs the Committee on Oversight to immediately discontinue any impeachment investigation or related inquiry premised upon, derived from, or substantially connected to the dismissed charge.

The Committee shall cancel any scheduled hearings, meetings, or deliberations concerning this matter. All agenda items, investigative proceedings, draft findings, or preparatory materials associated with the inquiry shall be formally withdrawn. Any actions taken solely in furtherance of the now-dismissed charge shall be concluded without further consideration.

This directive is issued to preserve procedural clarity and institutional consistency. The termination of the judicial proceeding renders continued impeachment review on the same underlying charge improper. The Committee on Oversight is expected to take all necessary administrative steps to effectuate the closure of this matter.

Conclusion:

The Judicial Council hereby dismisses the charges filed on January 22, 2026, against Director Zyna Navarte. This dismissal is procedural and results from the petitioner's voluntary request. It does not represent a finding in favor of or against any party. It is not commentary on the character, integrity, or professionalism of Ms. Rock or Director Navarte.


